Background

Sixteen counties in California received funding to develop a Quality Rating & Improvement System (QRIS) to improve early childhood education systems. In the Bay Area, 6 First 5 county commissions including Alameda, Contra Costa, Santa Clara, Santa Cruz, San Mateo, and San Francisco are collaborating to leverage the grant to increase the quality of early care and education for children across the region.

The Bay Area Quality Rating and Improvement System Partnership will be assessing child care programs using a matrix based on the state of California's Race to the Top Early Learning Challenge Grant Quality Continuum Framework.

One of the tools used to assess child care quality is the Environmental Rating Scales (ERS). Participating early care and education sites must have an independent external assessor administer the appropriate Environmental Rating Scale observation.
