Our goal is to further operationalize the Communications and Systems Change focus area of F5SMC's Strategic Plan through enhanced outreach, usage, and distribution of the Kit for New Parents.

POSSIBLE PROGRAM ENHANCEMENTS

- Warm Line w/ resource person
- DVD to orient providers to contents so that they are more effective presenters. A bulleted list on the outside?
- Partner w/ top 5 employers in the county and have them provide the kit to employees who are going out on family leave (due to birth/adoption)
- Partner w/ Babies R Us
 - o Provide Babies R Us w/ coupons for free Kits to pass out to customers

- Partners know WHO we are distributing to (not just which partners order kits) then tailor outreach to target missed populations
 - o Track who gets the kits so we know domographics
 - o Who is getting them and who IS NOT (ie, men?)
 - o Track language
- Partner w/ local baby/child toy manufacturers to make collateral and put in Kit, ie, Klutz
- Train the Trainers model to increased distribution, ie,
 - o Northern county (Sherin @ OSH)
 - o Peer educators
 - o CPS Parenting classes/workshops
 - o WIC
 - o Madres of Pescadero
- Augment current parenting classes w/ Kit presentation/distributions

POSSIBLE CUSTOMIZED ITEMS

- Three books packaged as one customized item: one book per developmental stage
- If we are able to get kit distributed prenatally customized pieces around early care issues/items such as:
 - o breastfeeding
 - o Shaken baby
 - o Car seat safety
 - o Father involvement
 - o Nursing pads
 - o Teething ring
- Utilize back of CHI flyer so that it's not blank
- Use more visuals vs. words
