RECOMMENDATION

Adopt a resolution awarding and authorizing execution of a contract for the resurfacing of portions of Airport Street near Pillar Point Harbor and Pescadero Creek Road in the Loma Mar Area.

Previous Board Action

- 1) Approved Plans and Specifications, determined prevailing wage scales and called for sealed proposals for the above mentioned project.
- 2) Authorized the Director of Public Works to enter into Agreements with local agencies or utilities to provide for the adjustment of facilities to grade as part of a County project, and for the reimbursement to the County for the costs incurred for the adjustment of said facilities.

Discussion

On Tuesday, July 17, 2001, bids were accepted for this project and subsequently referred to this office for checking and recommendation. The bids have been checked and the bid of:

at \$394,000 was the lowest bid received.

The Engineer's estimate was \$440,000. A summary of the bids received is as follows:

We have reviewed the contract documents and have determined the Affirmative Action Program and Equal Benefits Compliance Declaration Form submitted by **Granite Rock, dba Pavex Construction Division**, are in accordance with the current Affirmative Action Guidelines and the County Equal Benefits Ordinance.

Fiscal Impact

The total estimated cost for construction and contingencies is \$433,000.00, which includes a ten percent (10%) contingency as the work is bid on a unit price basis (i.e., per ton for asphalt concrete placed, square yard of pavement fabric, etc.). The contingency is used to pay the Contractor for any additional material placed as the actual tonnage used depends on the unit weight of the asphalt concrete and the tolerances for the actual thickness of the pavement placed.


The project will be financed as follows:

Road Fund	\$430,900
Montara Sanitary District	\$ 900
Coastside County Water District	\$ <u>1,200</u>
Total Estimated Cost	\$433,000

Road Funds for this work were approved in the 2001-2002 Road Fund Budget and the Director of Public Works, as previously authorized by your Board, will execute agreements with the two Districts for their work.

There is no impact to the General Fund.

A form of resolution has been approved by County Counsel.

**Resolution Awarding and Authorizing Execution
of a Contract for the Resurfacing of Portions of Airport Street Near Pillar Point Harbor
and Pescadero Creek Road in the Loma Mar Area**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on June 19, 2001 adopt Resolution No. 64551, which Resolution adopted the Plans and approved the Specifications, determined the prevailing wage scales and called for sealed proposals for the resurfacing of Portions of Airport Street Near Pillar Point Harbor and Pescadero Creek Road in the Loma Mar Area; and

WHEREAS, the Clerk of this Board of Supervisors did, in public on July 17, 2001, open and examine all sealed proposals that were received in the specified time for the doing of the work referred to in said Resolution No. 64551; and

WHEREAS, this Board of Supervisors has caused an analysis of said sealed proposals to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

WHEREAS, the lowest responsible bid was submitted by **Granite Rock, dba Pavex Construction Division** in the amount of **Three Hundred Ninety-Four Thousand and 00/100 Dollars (\$394,000.00)** based on an estimate of the amount of work to be done:

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. That it is in the best interest of the County of San Mateo to award the contract for the Resurfacing of Portions of Airport Street Near Pillar Point Harbor and Pescadero Creek Road in the Loma Mar Area to:

**Granite Rock
Dba Pavex Construction Division
330 Blomquist Street
Redwood City, CA 94063**

2. That the County of San Mateo shall enter into a written contract with **Granite Rock, dba Pavex Construction Division** for the doing of said work as required by the Plans and Specifications therefor adopted and approved by this Board of Supervisors, as hereinbefore mentioned, said Plans and Specifications being on file in the office of the Director of Public Works of the County of San Mateo.

3. That the President of this Board of Supervisors shall be, and is hereby, authorized and directed, for and on behalf of the County of San Mateo, to enter into said written

contract with **Granite Rock, Pavex Construction Division** for doing of said work, as hereinbefore mentioned and to receive and approve the Faithful Performance Surety Bond and the Labor and Material Surety Bond required to be posted by the said Contractor with the County of San Mateo in connection therewith.

4. That all payments to the Contractor be in accordance with the Plans, Specifications, and other contract documents, based on the Director of Public Works' written estimates of work actually done.

5. That, Paragraph 4 above notwithstanding, aggregate payments to Contractor shall not exceed the sum of **Four Hundred Thirty-Three Thousand and 00/100 Dollars (\$433,000.00)** without this Board's prior approval.

6. That the Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written contract.
