Consideration of a Resolution approving Agreement for the Exclusive Right to Negotiate and Purchase certain real property located in unincorporated El Granada, Approval of Appropriation Transfer Request, and Identification of Property and Negotiators Pursuant to Government Code section 54956.8

> **RECOMMENDATION:** (1) Adopt a resolution approving an Agreement for the Exclusive Right to Negotiate and Purchase the property located in unincorporated El Granada commonly known as Mirada Surf; (2) approve an Appropriation Transfer Request (ATR) transferring \$250,000 from Non-Departmental Reserves to Land Acquisition Expense in the Parks Acquisition and Development budget; and (3) identify the County's negotiator, the property subject to negotiations, and the persons with whom County may negotiate.

The owners of the real property located in unincorporated El Granada commonly known as Mirada Surf have approached the County with a proposal to sell the property to the County of San Mateo. The property consists of 49 acres, most of which is adjacent to and east of Highway 1. The most recent development application for the property included an 18 acre residential development east of Highway 1 and dedication of a 16 acre Shoreline Parcel and 15 acre Hillside parcel for preservation as permanent open space.

The property owners have given the County a limited time period to consider the proposal. The owners have provided an appraisal of the property, but it is recommended that the County undertake its own appraisal before proceeding with negotiations or purchase. This will take some time to complete. Therefore, in order to protect the County's ability to consider the owners' proposal, it is recommended that the Board approve an Agreement for the Exclusive Right to Negotiate and Purchase the Property for a term of six (6) months. In return for this exclusive right, the County will pay \$250,000.00 which approximates the amount of interest on the fair market value stated in the owners' appraisal for a six-month period. This payment would be credited toward the purchase price should the County purchase the property.

In order to fund the Agreement, we recommend that the Board approve an Appropriation Transfer Request (ATR) transferring \$250,000.00 from Non-Departmental Reserves to Land Acquisition Expense in the Parks Acquisition and Development budget.

Finally, Government Code section 54956.8 allows a legislative body to meet in closed session under certain circumstances to give authority to its negotiator regarding the price and terms of payment for the purchase or sale of real property. However, prior to the closed session, the legislative body must hold an open and public session in which it identifies its negotiators, the real property which the negotiations concern and the person(s) with whom its negotiator may negotiate. We recommend that the Board identify (1) the County Manager as the County's negotiator, (2) the property as the Mirada Surf property located in unincorporated El Granada, more particularly described in Exhibit A to the Agreement for Exclusive Right to Negotiate and Purchase, and (3) the persons with whom the County's negotiator may negotiate as the law firm of McCracken, Byers & Haesloop.
