Subject: County Real Property Planning

At the December 19, 2000 Board of Supervisors meeting, the Board was presented with the annual report of County Owned Real Property. Included was a description of properties deemed surplus and recommendations for possible use or disposition

Both Supervisor Jacobs-Gibson and I inquired about a listing of space leased for County facilities and whether the County's future needs are considered when County property is deemed surplus

Attached is a listing of all the property the County is currently leasing from other property owners. As you can see, there is a disparity in the amount charged for equivalent office space per square foot throughout the county. This will of course continue to change as leases expire, are renewed, or rents increase.

In certain instances, the amount to be paid over the term of a lease (assuming no increases) would pay for the purchase of a building. For example, Human Service Agency offices at 400 Harbor in Belmont are leased for \$153,699.23 a month, or \$1,844,390.80 a year. With the lease expiring on May 31, 2008, the total the county will pay from now until then, with no increases, is \$15,523,622.15. Likewise, over the term of other leases, the County will pay millions of dollars. We should not allow ourselves to be put in a position where so much money is spent on rent rather than on employees and programs.

The demand for County office space will only continue Between 1995 and June of 2000, the County hired an additional 306 employees. While this increase took place during prosperous economic times, we cannot be blind to the reality that our workforce will continue to grow as more programs are mandated of counties. With the passage of Proposition 36, counties will be responsible for implementation of substance abuse rehabilitation programs. We will have to find appropriate locations (and given our experiences with the Homeless Shelter and the Methadone Clinic this past year, we know the difficulty) and potentially new employees to manage the programs.

With these ideas in mind, and given the real estate market in San Mateo County, I believe it is unwise for the County to dispose of any real property without first determining the feasibility for current or future County use. We should also begin to plan for future County real property needs

We are in the final stages of the County's Visioning Project. The process has focused on the broader community and where we would like to be in ten years. County departments have played a vital role in shaping and incorporating components of the Vision. I believe that in keeping with the Visioning goals under Partnerships, we need to look at decisions we make now and their future impact as it pertains to where we and our employees will physically be located - not just ten years from now, but in twenty, thirty and beyond

Therefore, I propose that

- Prior to deeming property as surplus, a specific evaluation is made for potential use as a County facility, taking into account the current and future needs of all County departments
- 2. In the event the County property is considered surplus, all proceeds from the sale should go into a fund for the purpose of reducing the County rental cost, whether through purchase of existing facilities or new construction
- 3 A Board Sub-Committee be appointed to work with Department Heads and staff to
 - a study our current space needs and anticipated future demands, taking into consideration the possibility of remodeling, reusing or retrofitting existing structures,
 - b recommend possibilities for departments to collaborate on consolidation of offices with the goal of purchasing facilities or new construction on existing County real property;
 - c recommend possibilities for collaboration with other organizations (city governments and non-profits) whether for purchase and/or new construction as a partner with the County, or lease of said real property from the County
