# RECOMMENDATION

Adopt a resolution authorizing the In-Home Supportive Services (IHSS) Public Authority employees to participate in the CalPERS 457 Deferred Compensation Program

# Background

On March 29, 1994, you adopted a resolution establishing staff positions for the IHSS Public Authority and determining that Public Authority staff would participate in the County's employee benefits program, receiving the same type of benefits as county employees. However, it was determined that since the IHSS Public Authority was not a county agency, its employees would not be able to participate in the County's retirement program. On October 10, 1995, you adopted a resolution approving a contract with the California Public Employees' Retirement System (CalPERS) to allow the employees of the IHSS Public Authority to participate in CalPERS. On December 21, 1999 you adopted a resolution to continue provisions of Section 414 (h) (2) IRC, which enables Public Authority employees to defer State and Federal income taxes on their own contributions to CalPERS.

## Discussion

CalPERS is now offering the CalPERS 457 Deferred Compensation Program to its members. This program allows CalPERS' participants to invest money for their retirement through a variety of mutual funds The options offered by CalPERS 457 are similar to those offered by other deferred compensation programs, but they are provided at a lower fee because of the large number of employees involved in the program

CalPers requires a resolution executed by the IHSS Public Authority Board in order to offer this plan to the Public Authority employees

Fiscal Impact

WHEREAS, this Governing Board supports the participation of the Public Authority employees in the CalPERS Deferred Compensation Program; and

WHEREAS, CalPERS requires that the Public Authority execute a resolution authorizing the participation of its employees in the CalPERS 457 Deferred Compensation Program:
