APPROVAL OF AN APPROPRIATION TRANSFER REQUEST TO INCREASE THE APPROPRIATION AND REVENUE TO ADD FUNDING FOR THE PROVISION OF FUNDING FOR FOSTER CARE CHILD CARE; KINSHIP FAMILIES RESPITE; AND TRAINING FOR CHILD CARE PROVIDERS IN THE AMOUNT OF \$249,787 FOR FISCAL YEAR

### Recommendation

Approval of an Appropriation Transfer Request (ATR) to increase the appropriation and revenue to add funding for the provision of funding for foster care child care; kınshıp families respite; and training for child care providers in the amount of \$249,787 for Fiscal Year 2000-2001;

#### **Background**

On January 23, 2001, your Board approved an Agreement between the County of San Mateo and the Children and Families First Commission of San Mateo County for the provision of funding for foster care child care; kinship families' respite; and training for child care providers in the amount of \$1,353,683 for Fiscal Years 2001-2003.

#### **Discussion**

The Agreement with the Children and Families First Commission of San Mateo County includes funding to HSA for direct payments to child care providers for child care services to foster and kinship families; funding for a subcontract with the Edgewood Kinship Support Services Program to identify and refer kinship families to the respite; and funding for a subcontract with the Child Care Coordinating Council to provide training to child care providers to care for foster and kinship children. Agreements with these subcontractors will be forwarded to the County Manager for execution HSA will serve as lead agency, providing overall management of all services.

#### **Fiscal Impact**

The Appropriation Transfer Request (ATR) is in the amount of \$249,787 for Fiscal Year 2000-2001. HSA will retain funds in the amount of \$215,505 for Fiscal Year 2000-2001, for the period January 1, 2001 through June 30, 2001, for the provision of direct payments to child care

providers (\$194,860) and operating expenses (\$20,645) for foster and kinship families child care program. The subcontract with the Edgewood Kınship Support Services Program will be in the amount of \$17,500 for Fiscal Year 2000-2001 for the period January 1, 2001 through June 30, 2001. The subcontract with the Child Care Coordinating will be in the amount of \$16,782 for Fiscal Year 2000-2001 for the period January 1, 2001 through June 30, 2001. There is no net county cost related to the approval of this ATR or the agreements for services.
