I am pleased to report that the Year 2001 Charitable Contributions Campaign was very successful County employees have pledged to contribute \$120,987 for the year 2001, an increase of 23% over the amount raised in 2000 I would also like to note that contributions have more than tripled over the past ten years

A special thanks is due to Marcia Raines and the Environmental Services Agency staff as well as the individual coordinators for each of the various County departments They all worked diligently to make the 2001 campaign a big success

Attached is a comprehensive report that illustrates the amount of County employee contributions by charity and department For 2001, the Children/Adult Fund split into separate Funds creating a total of 10 worthwhile charities to which employees chose to donate
