Background:

According to Elections Code §10002, the governing body of any city or district may request the Board of Supervisors of the County to permit the County Elections Official to render specified services to the city or district relating to the conduct of an election. Subject to approval of the Board of Supervisors, these services shall be performed by the Chief Elections Officer.

Discussion:

In accordance with Government Code §§53326 and 53327, and Elections Code §10002, resolutions were filed requesting the Chief Elections Officer to perform specified election services in conjunction with the Special Election to be held on June 5, 2001

It is in order for your Honorable Board to authorize the Chief Elections Officer to render specified election services for the above districts. We respectfully request that our recommendation be approved.

WHEREAS, pursuant to the California Government Code and California Elections Code, the Town of Atherton adopted Ordinance No 520 calling for the submission of a special tax measure to the voters of the Town of Atherton, and

WHEREAS, pursuant to the California Government Code and California Elections Code, the City of Millbrae adopted Resolution Nos 01-26 and 01-34 and Ordinance No. 664 calling for the submission of a bond measure to the voters of the City of Millbrae, and

WHEREAS, pursuant to the California Government Code and California Elections Code, the City of San Bruno adopted Resolution Nos 2001-15 and 2001-18 regarding the construction of a Navy Site and calling for the submission of an Initiative Ordinance to the voters of the City of San Bruno; and

WHEREAS, pursuant to the California Government Code and California Elections Code, the City of San Bruno Ordinance No 1637 and Resolution Nos 2001-14 and 2001-17 calling for the submission of a bond measure to the voters of the City of San Bruno; and

WHEREAS, pursuant to the California Government Code, California Education Code, and California Elections Code, the Governing Body of the Belmont-Redwood Shores School District

adopted Resolution No. 19 calling for the submission of a special tax measure to the voters of the Belmont-Redwood Shores School District, and

WHEREAS, pursuant to the California Government Code, California Education Code, and California Elections Code, the Governing Body of the Sequoia Union High School District adopted Resolution No. 1165 calling for the submission of a bond measure to the voters of the Sequoia Union High School District; and

WHEREAS, the Chief Elections Officer has been asked to perform certain services in conjunction with these elections; and

WHEREAS, the Chief Elections Officer is agreeable to providing these election services to the Cities and School Districts, and

WHEREAS, in consideration of services and supplies provided by the Chief Elections

Officer, the Town of Atherton, City of Millbrae, City of San Bruno, Belmont-Redwood Shores

School District, and the Sequoia Union High School District will reimburse the County for the costs of these services and supplies
