**SUBJECT:** Resurfacing of Gilman, Larchmont, and Mac Arthur Drives - Broadmoor Village Area (Project No. R5P01-F36[357])

**RECOMMENDATION**

Adopt a resolution adopting plans and specifications, determining prevailing wage scales, and calling for sealed proposals for the Resurfacing of Gilman, Larchmont, and Mac Arthur Drives.

**Previous Board Action**

Authorized the Director of Public Works to proceed with the preparation of plans and specifications for resurfacing type projects on various County roads utilizing funds available to the County pursuant to Assembly Bill 2928 (AB2928).

**Key Fact**

The proposed project is part of our overall program to preserve the County maintained road system.

**Discussion**

The proposed project, totaling approximately 1.48 miles in length, consists of the repair of failed areas of pavement, the installation of pavement reinforcing fabric, and the resurfacing of the roads with asphalt concrete within the limits shown on the attached location map.

The San Mateo County Planning Department has determined that this project is exempt from the requirements for preparation of an Engineering Impact Report under Section 15301(C) Class 1, of the California Environmental Quality Act (CEQA) and we have filed a Notice of Exemption with the County Clerk.

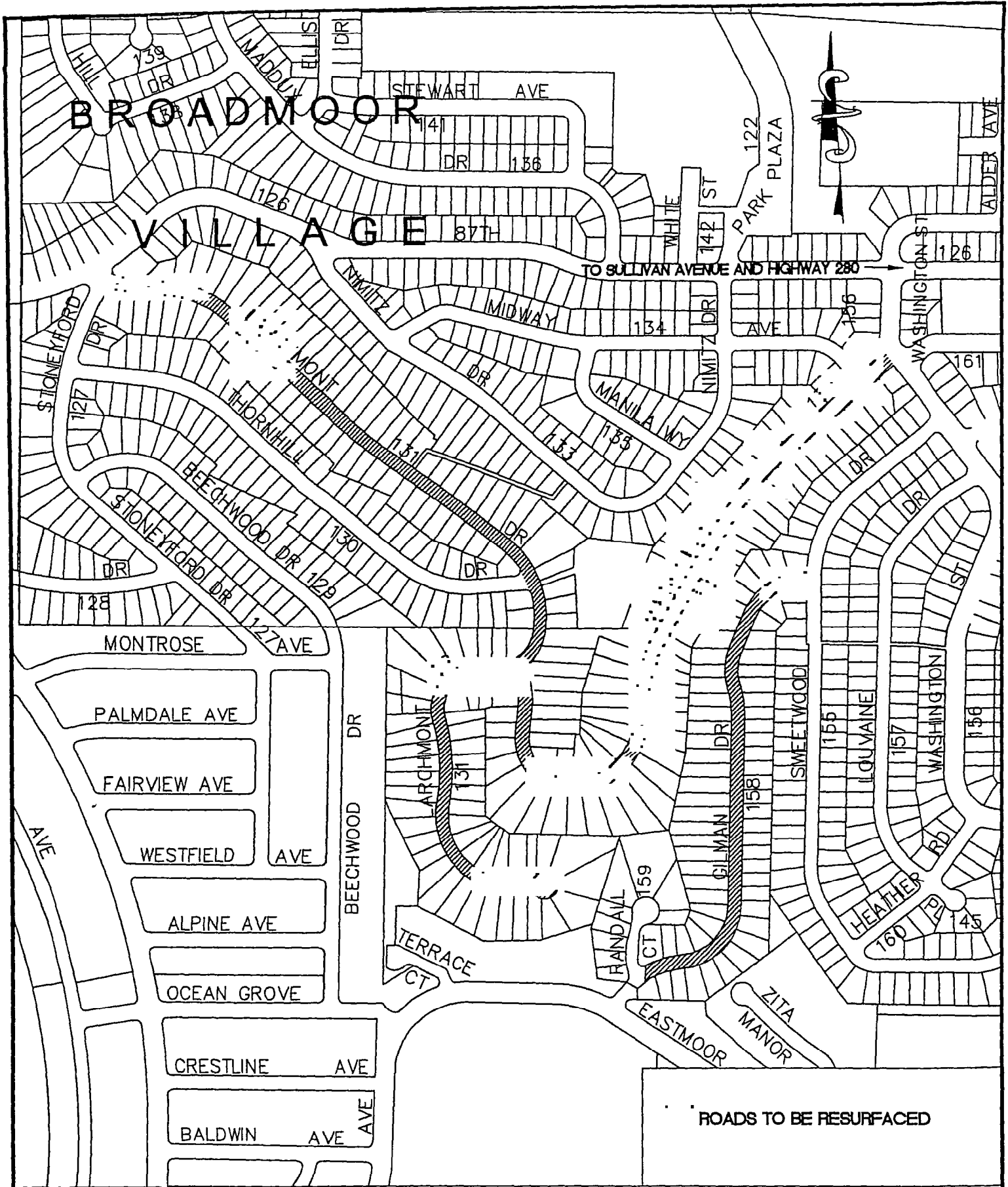

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Plans and Specifications have been prepared and approved by the Director of Public Works for the resurfacing of portions of Gilman, Larchmont, and Mac Arthur Drives in Broadmoor Village Area, and said Plans and Specifications have been filed in the office of the Director of Public Works; and

**WHEREAS**, a schedule of prevailing wage scales for each craft or type of workman needed to execute this contract in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said Specifications.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

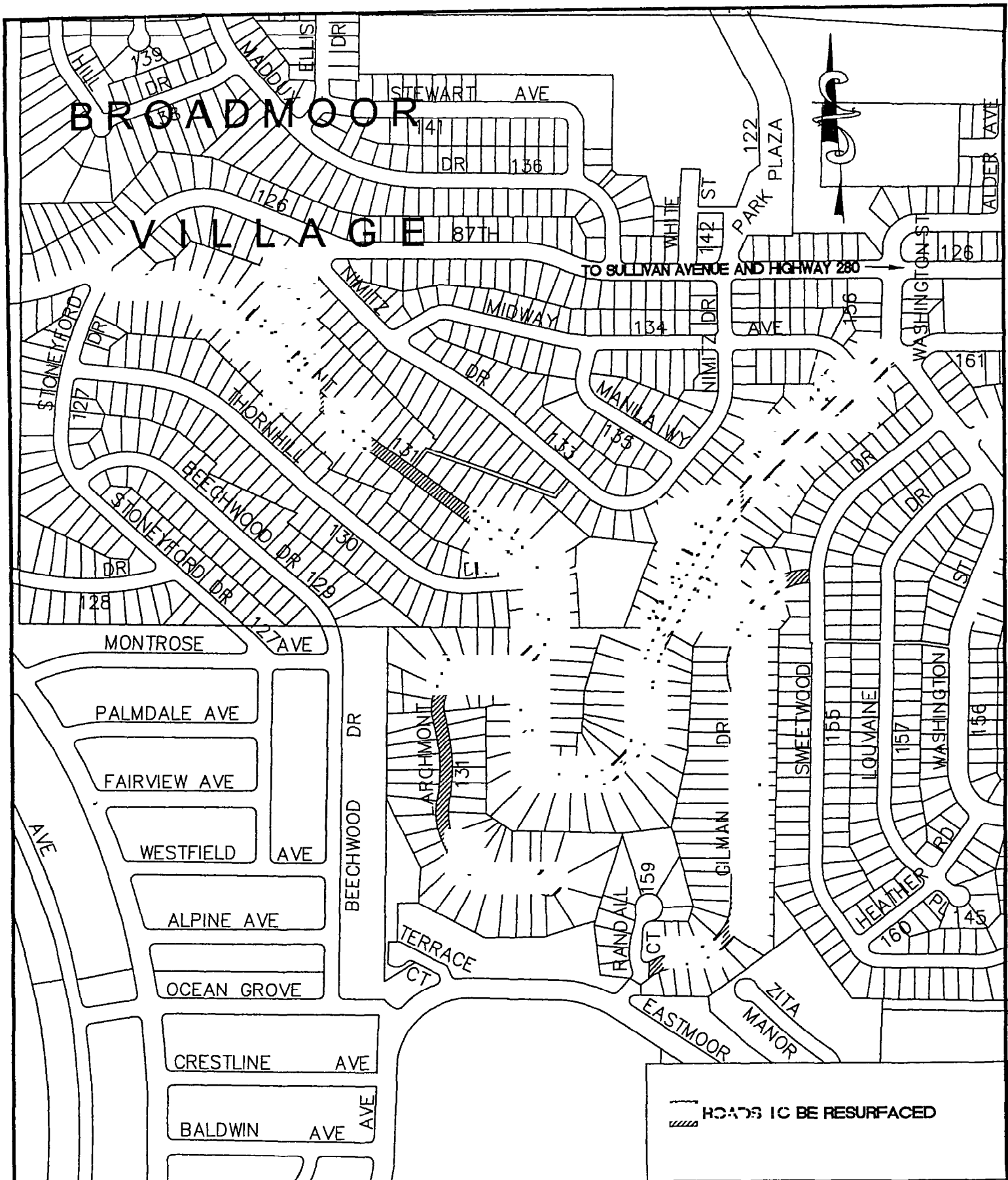
1. The Plans and Specifications dated April 6, 2001, for the aforementioned project, on file in the office of the Director of Public Works, to which reference is hereby made for further particulars, are hereby approved of and adopted as the Plans and Specifications to be adhered to in letting and performing the work under a contract for said improvements.

2. The schedule of prevailing wages referred to in said Specifications has been determined to contain the general prevailing rates of wages in the locality in which said work is to be performed for each craft or type of workman needed to execute said contract.

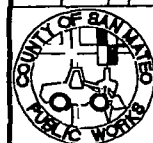
3. The Department of Public Works is authorized and directed to issue a call for sealed proposals to be received by the Clerk of the Board of Supervisors, County of San Mateo, on or before May 8, 2001 at 2:00 p.m. in said office in the Hall of Justice and Records, Redwood City, California; which bids will then be transmitted to the County Manager's Office in said Hall of Justice and Records and be publicly opened and declared.

The Department of Public Works is further directed to cause the Notice inviting sealed proposals to be published for two (2) times in the San Mateo County Times, a newspaper printed and published in this County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Clerk of the Board of Supervisors.
