**Subject:** Resurfacing of Various Roads in the Burlingame/San Mateo Area

### RECOMMENDATION

Adopt a resolution adopting plans and specifications, determining prevailing wage scales, and calling for sealed proposals for the Resurfacing of Skyline Boulevard, Canyon Road, Crystal Springs Road, Ascension Drive, Valley View Court and Bel Aire Road as shown on the attached maps

### Previous Board Action

Authorized the Director of Public Works to:

- 1) proceed with the preparation of plans and specifications for resurfacing type projects on various County roads utilizing funds pursuant to Assembly Bill 2928 (AB2928).
- 2) execute agreements with cities, utility companies and special districts for work less than \$25,000 proposed to be done in conjunction with County road projects

### Key Facts

1. The proposed project is part of our overall program to preserve the County maintained road system
2. The Parks Division of the Environmental Services Agency has requested that the entrance area to Sawyer Camp Trail near Crystal Springs Road also be included in this resurfacing project.
3. The City of Burlingame has requested the County to include, in its resurfacing contract the adjustment of various utility facilities and the resurfacing of the City's portion of Canyon Road
4. The Town of Hillsborough has requested the County to include, in its resurfacing contract, the adjustment of water facilities.

### Discussion

The proposed project, totaling approximately 4.60 miles in length, consists of pavement repair work, installation of pavement reinforcing fabric, and resurfacing of the roads with asphalt concrete within the limits shown on the attached map. The work also consists of the replacement of traffic striping and legends.

The San Mateo County Planning Department has determined that this project is exempt from the requirements for preparation of an EIR under Section 15301(C) Class 1, of the California Environmental Quality Act and we have filed a Notice of Exemption with the County Clerk.

**Fiscal Impact**


The total estimated cost of construction is \$789,000. The project will include the resurfacing of various roads, the resurfacing of the entrance area of Sawyer Camp Trail, the resurfacing of the City of Burlingame portion of Canyon Road, and the adjustment of various utility facilities for both the City of Burlingame and the Town of Hillsborough. The City work is described in the two agreements that will be executed by the Director as authorized by your Board.

The project will be financed as follows:

AB2928 Funds	\$766,350
Parks Division	\$ 3,000
City of Burlingame	\$ 19,200
Town of Hillsborough	\$ 450
Total Cost of Construction	\$789,000

There is no impact to the General Fund.

A form of resolution has been approved by County Counsel.



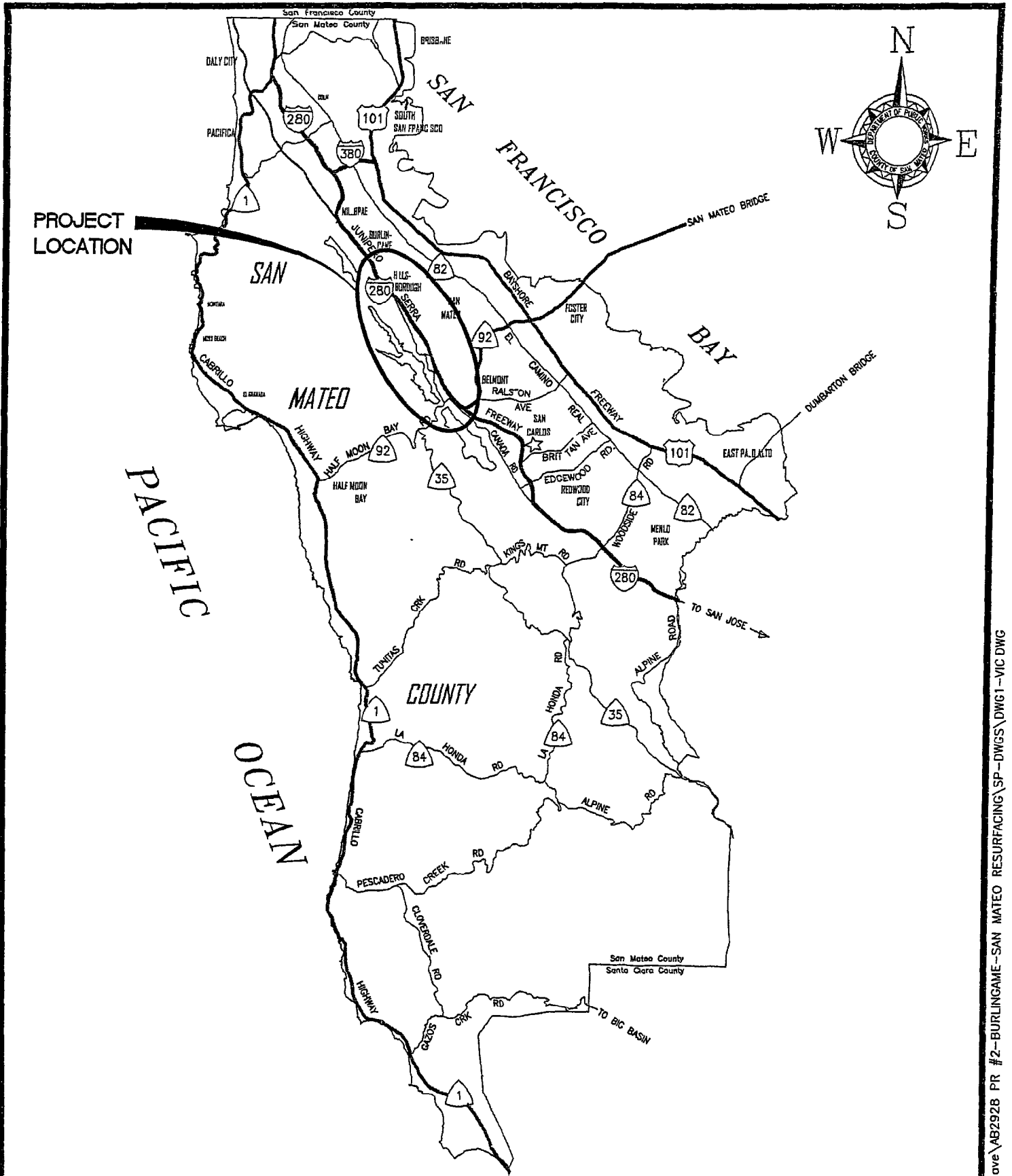

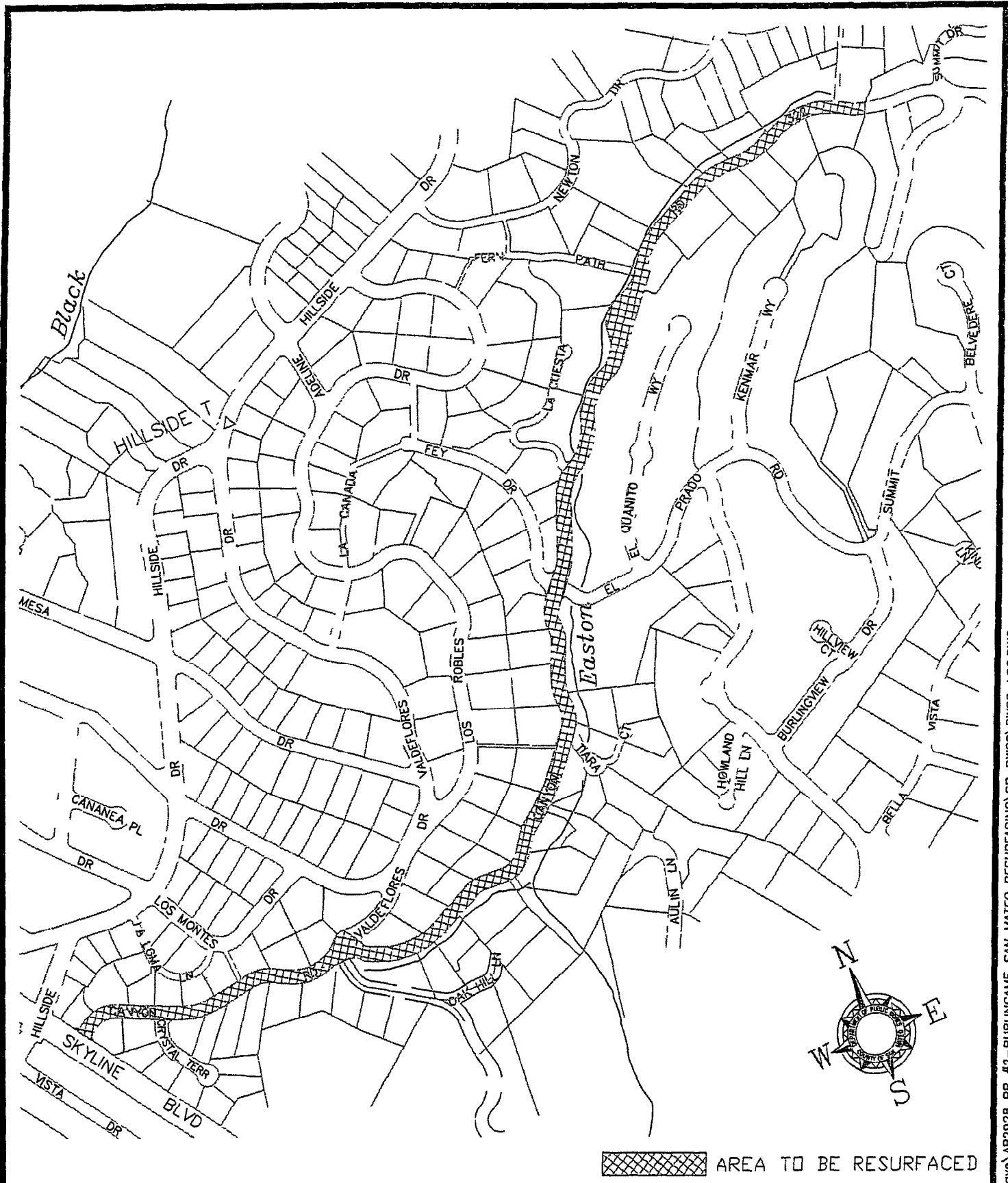

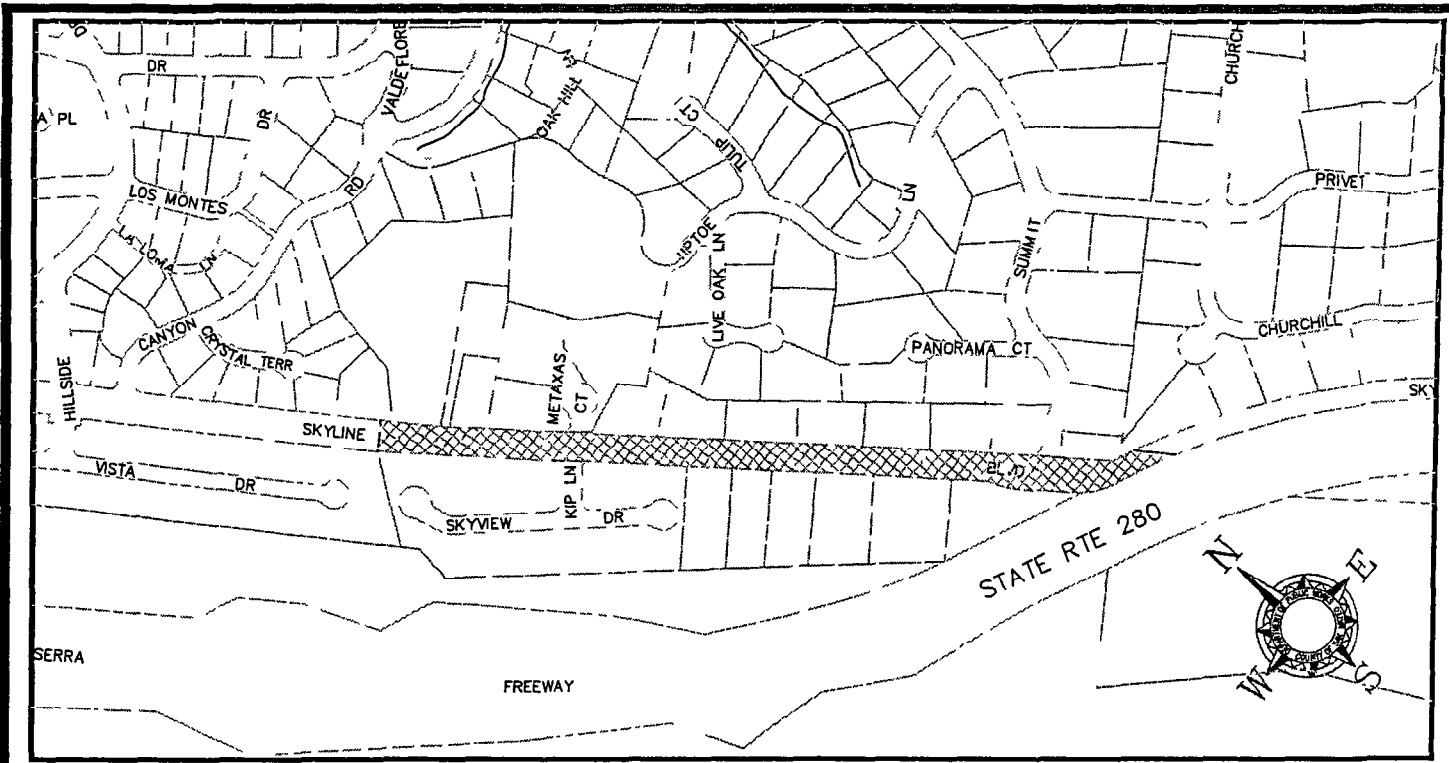
BURLINGAME/SAN MATEO

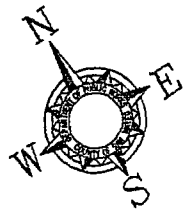
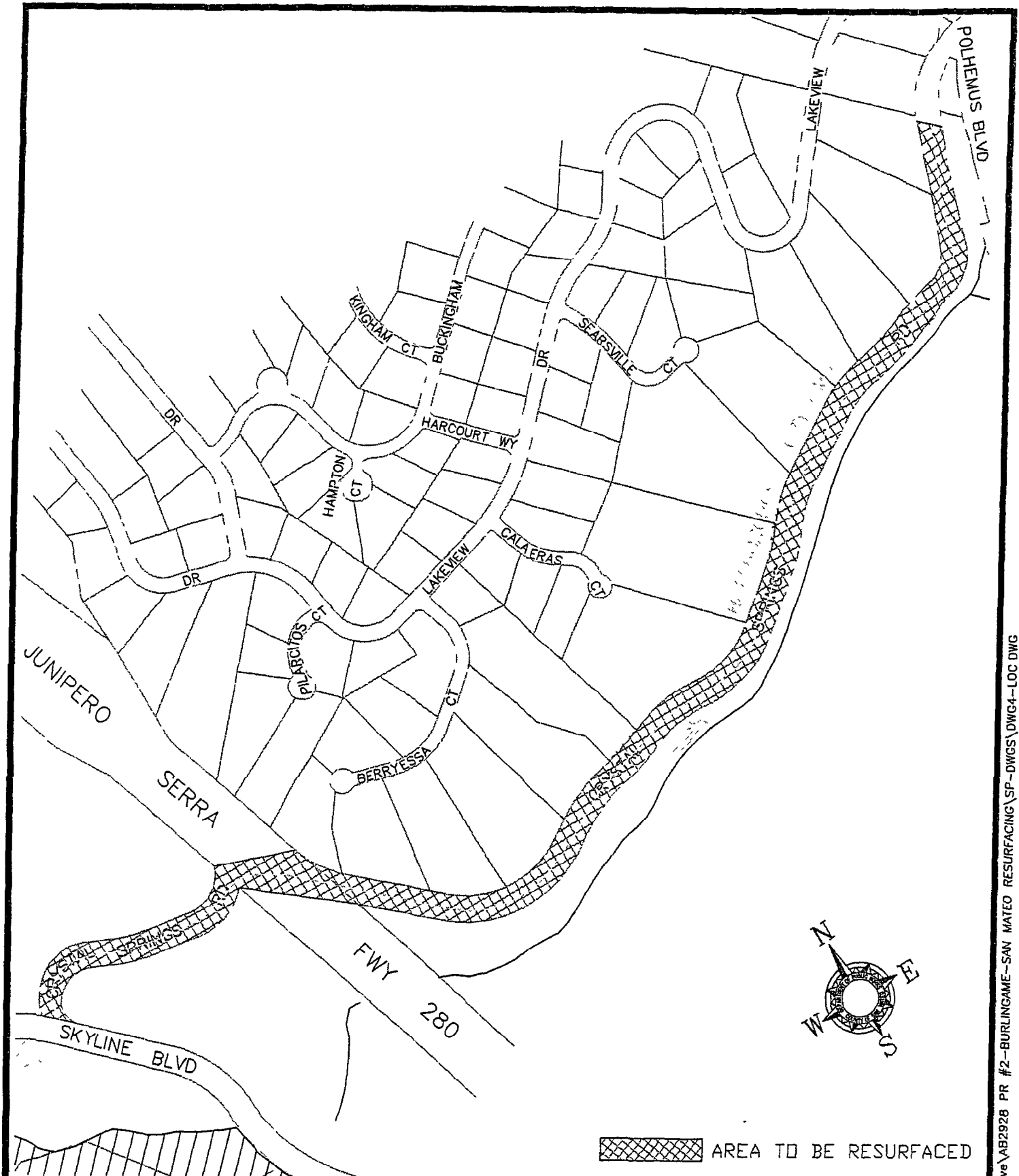
**BURLINGAME/SAN MATEO

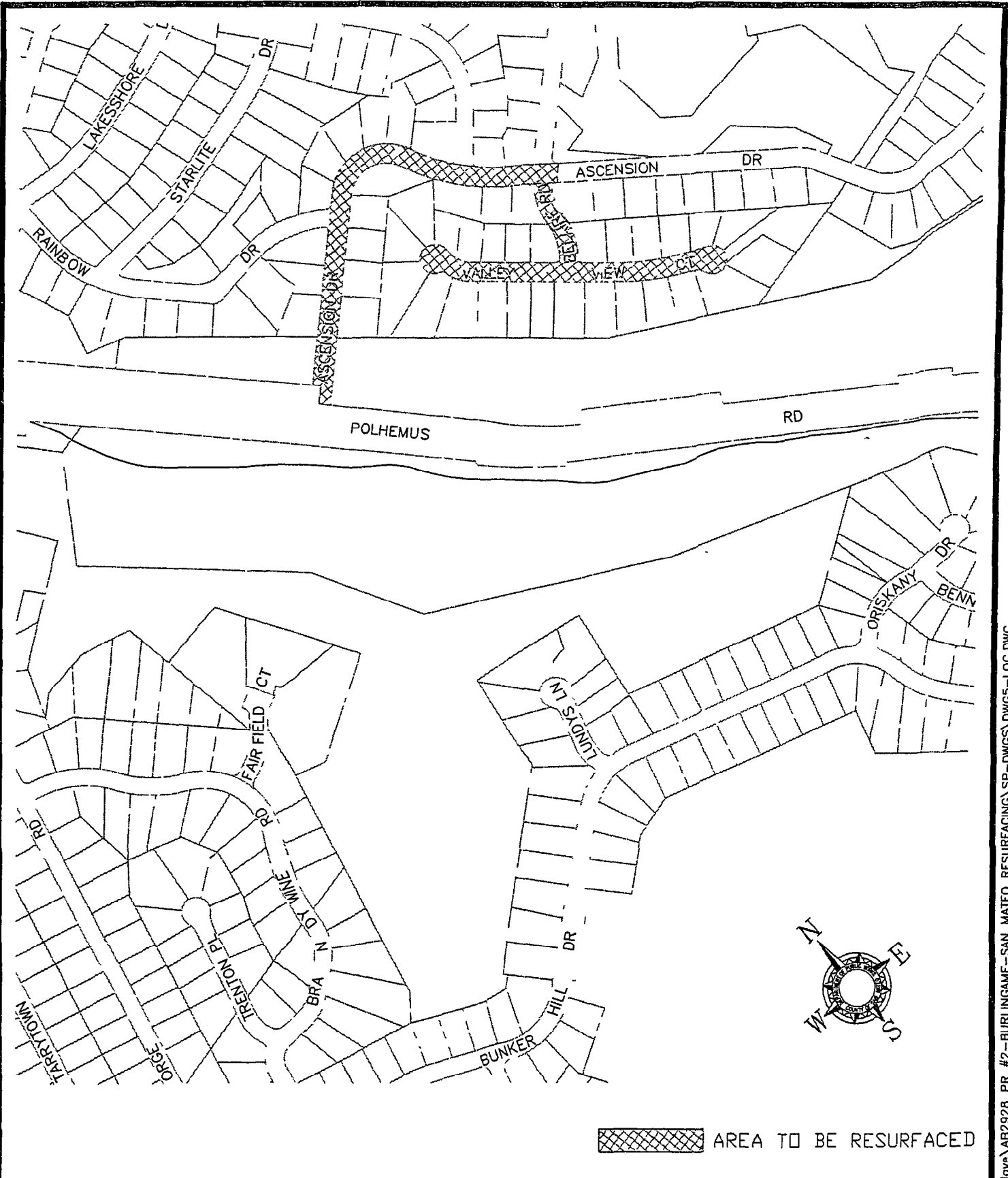
**BURLINGAME/SAN MATEO

**Resolution Adopting Plans and Specifications, Determining Prevailing Wage Scales and  
Calling for the Sealed Proposals for the**

**Resurfacing Project for Various Roads in the Burlingame/San Mateo Area**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Plans and Specifications have been prepared and approved by the Director of Public Works for the Resurfacing of a portion of Skyline Boulevard, Canyon Road, Crystal Springs Road, Ascension Drive, Valley View Court and Bel Aire Road as shown on Exhibit "A" attached hereto made a part hereof Said Plans and Specifications have been filed in the office of the Director of Public Works, and presented to this Board for its approval, and this Board has considered same; and

**WHEREAS**, a schedule of prevailing wage scales for each craft or type of workman needed to execute this contract in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said Specifications.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows

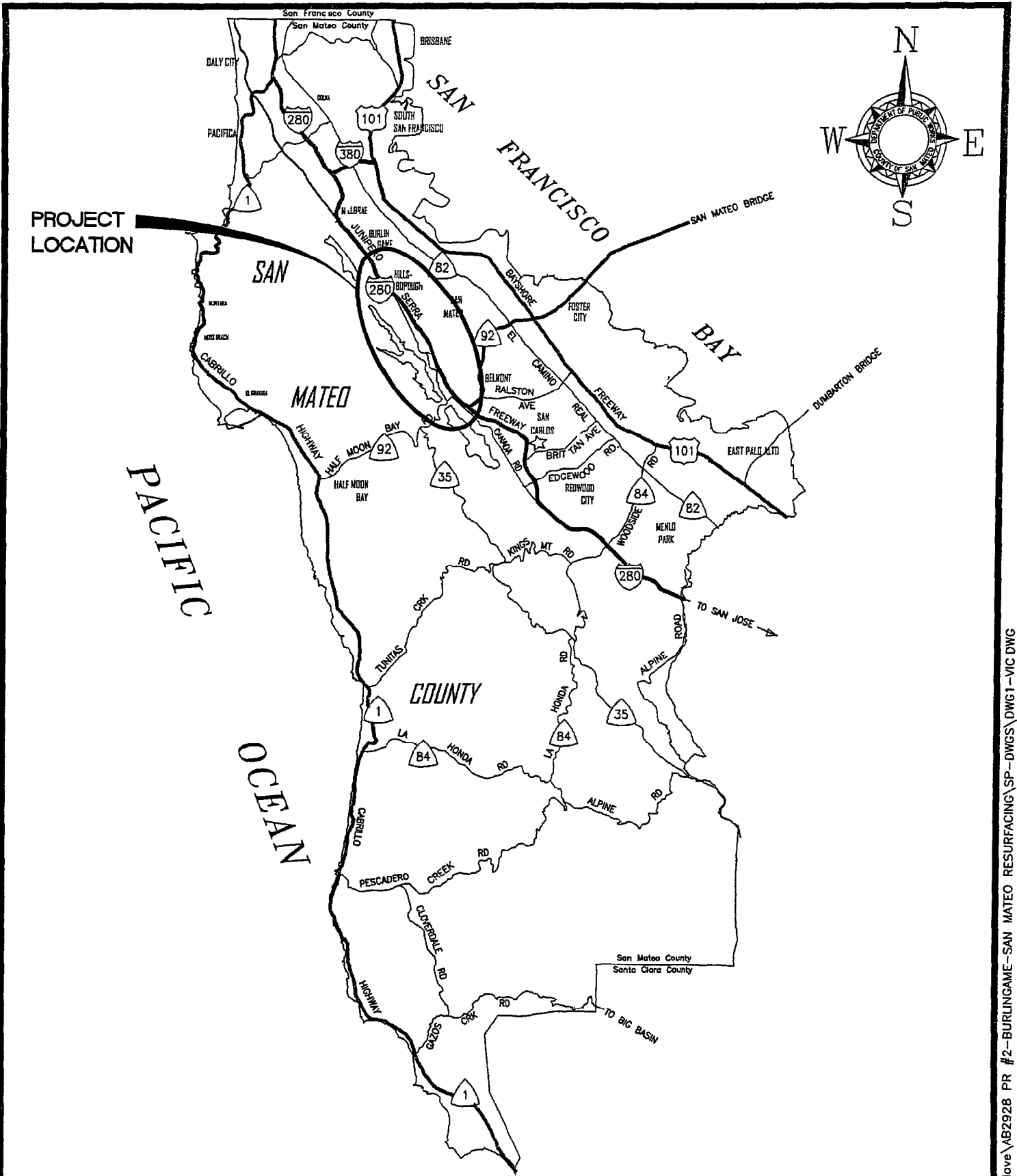
1. The Plans and Specifications dated April 20, 2001, for the aforementioned project, on file in the office of the Director of Public Works, to which reference is hereby made for further particulars, are hereby approved of and adopted as the Plans and Specifications to be adhered to in letting and performing the work under a contract for said improvements.

2. The schedule of prevailing wages referred to in said Specifications has been determined to contain the general prevailing rates of wages in the locality in which said work is to be performed for each craft or type of workman needed to execute said contract.

3. The Department of Public works is authorized and directed to issue a call for sealed proposals to be received by the Clerk of the Board of Supervisors, County of San Mateo, on or before May 22, 2001 at 2:00 p.m. in said office in the Hall of Justice and Records, Redwood City, California; which bids will then be transmitted to the County Manager's Office in said Hall of Justice and Records, and be publicly opened and declared

The Department of Public Works is further directed to cause the Notice inviting sealed proposals to be published for two (2) times in the Independent Newspaper Group, a newspaper printed and published in this County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Clerk of the Board of Supervisors.

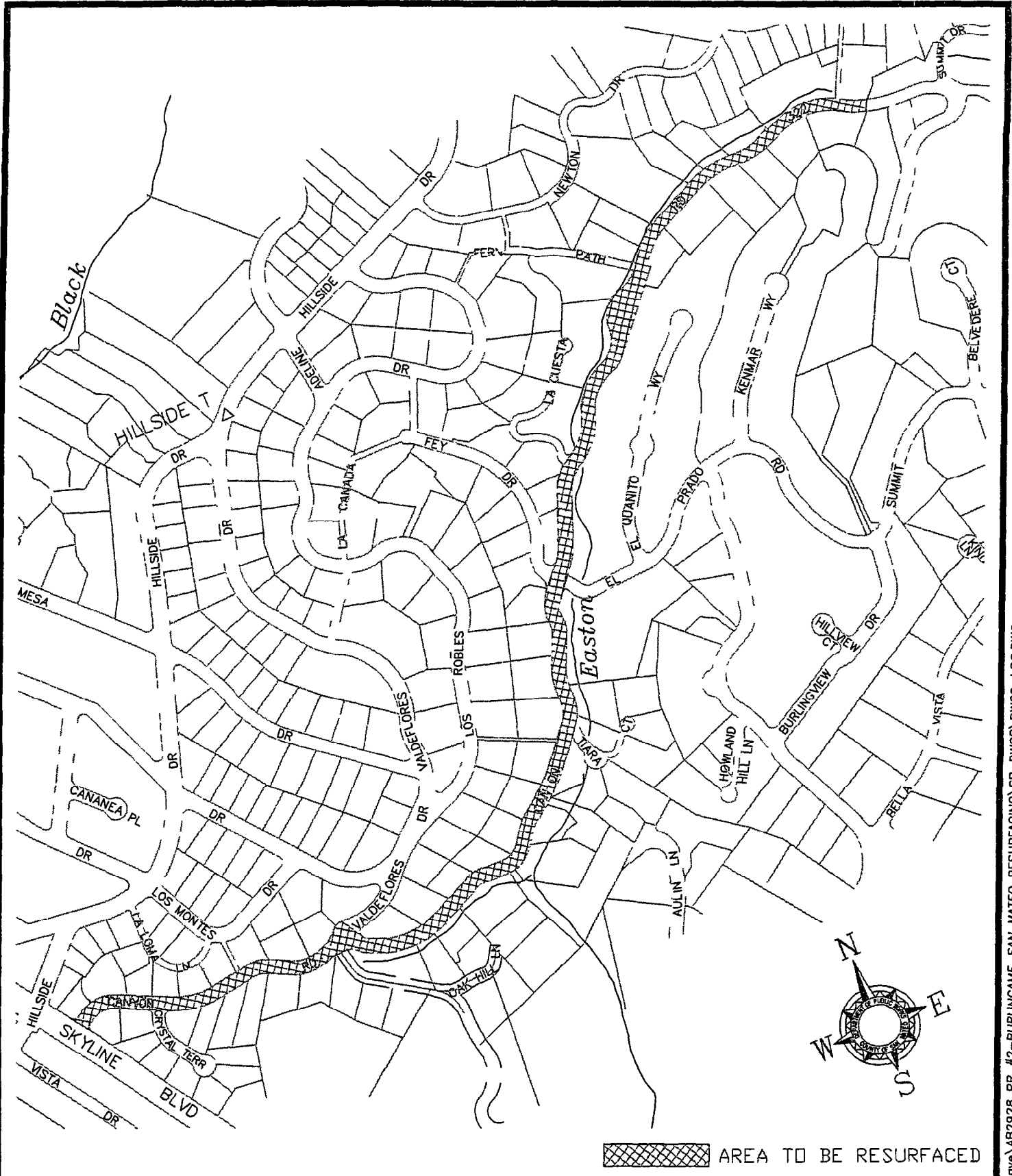
**BURLINGAME/SAN MATEO

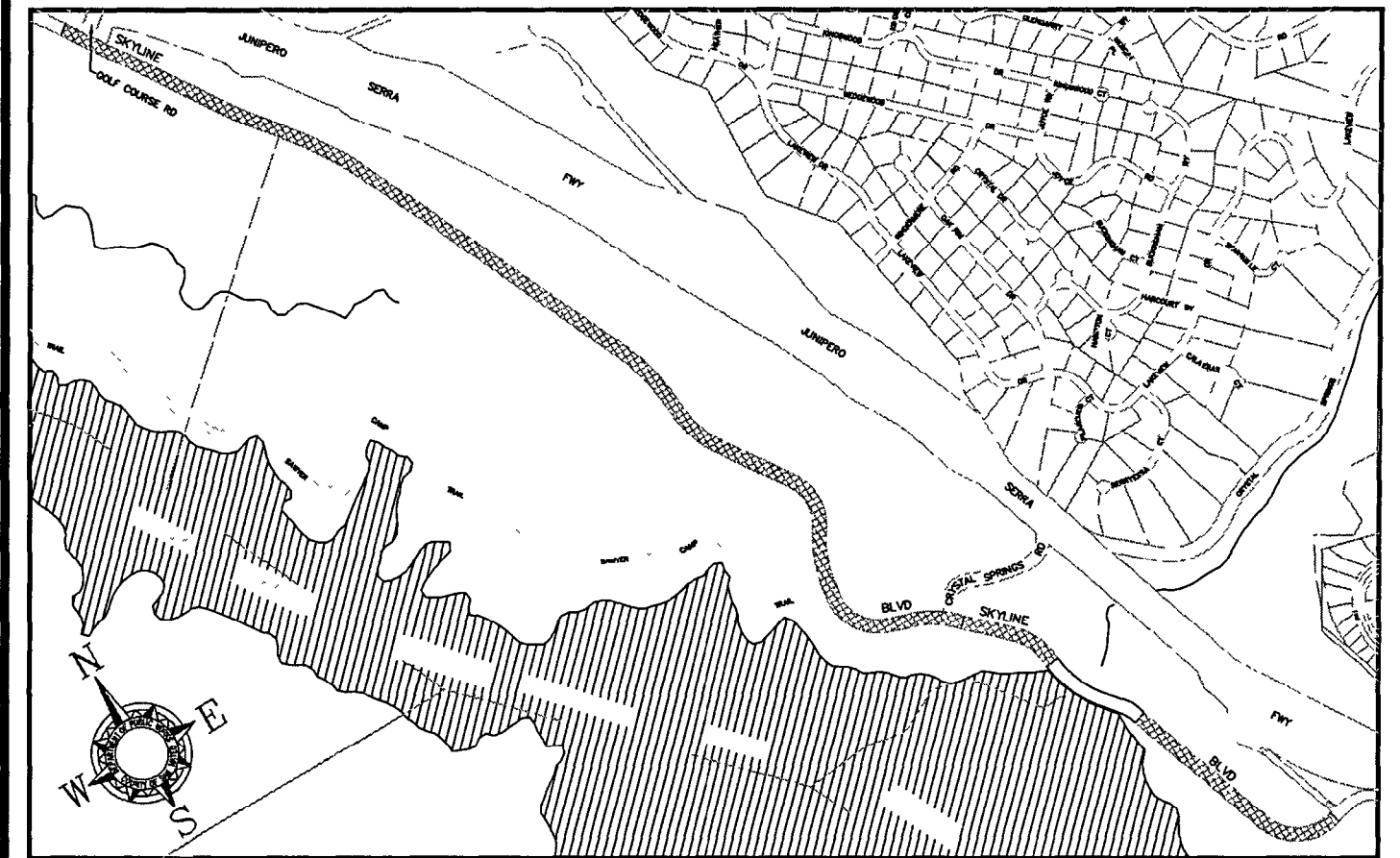
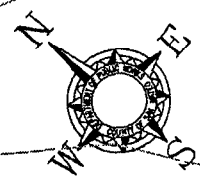
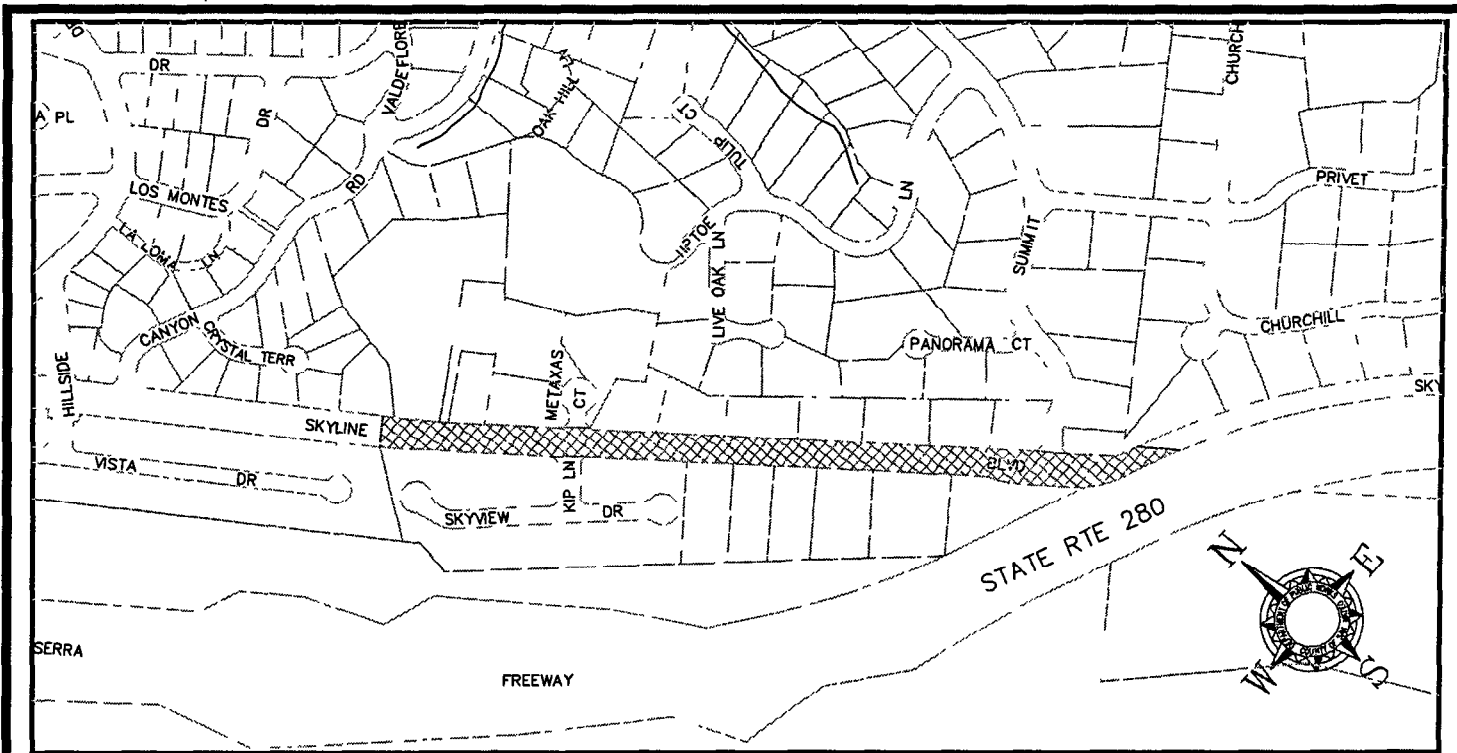
BURLINGAME/SAN MATEO

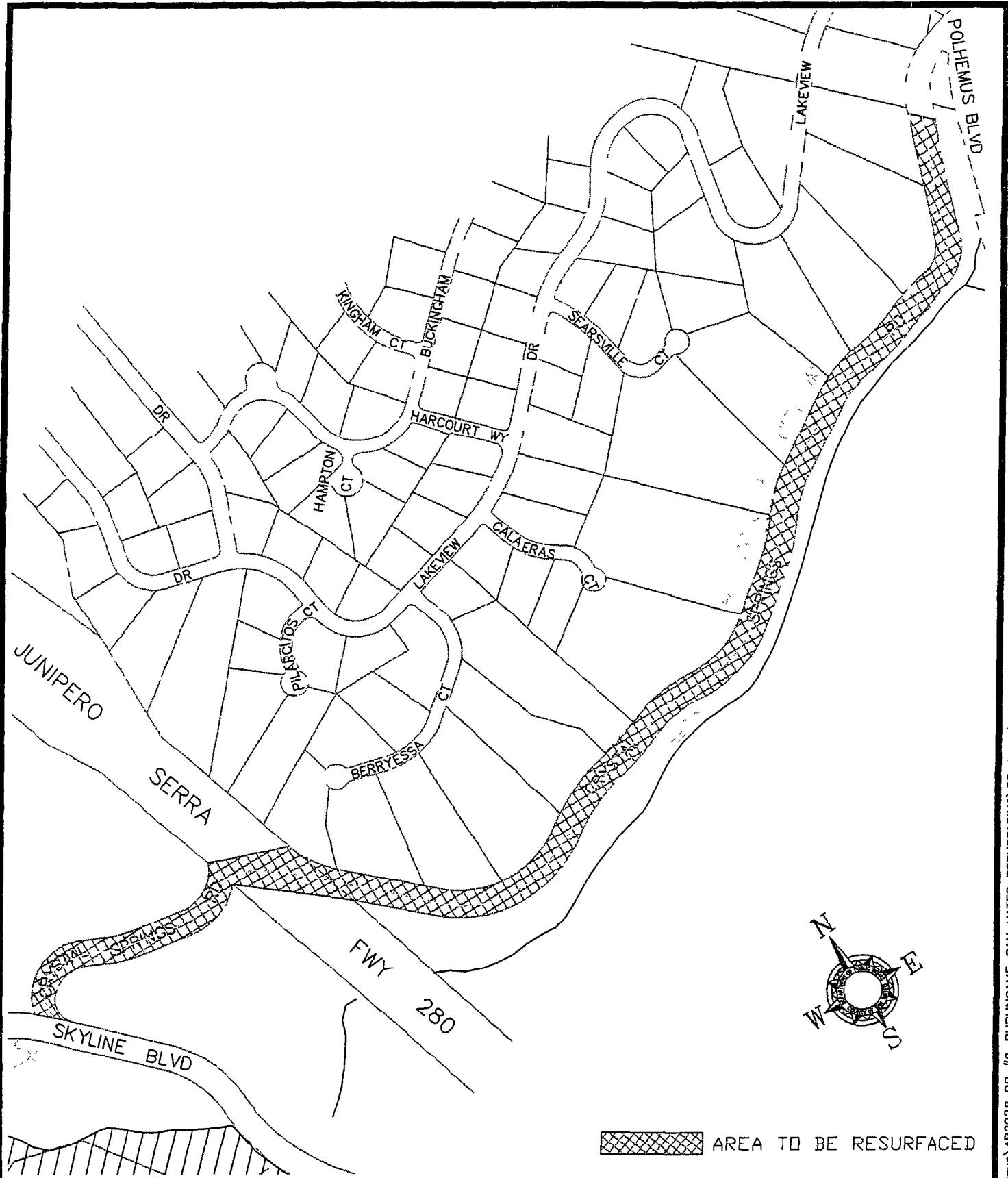
BURLINGAME/SAN MATEO

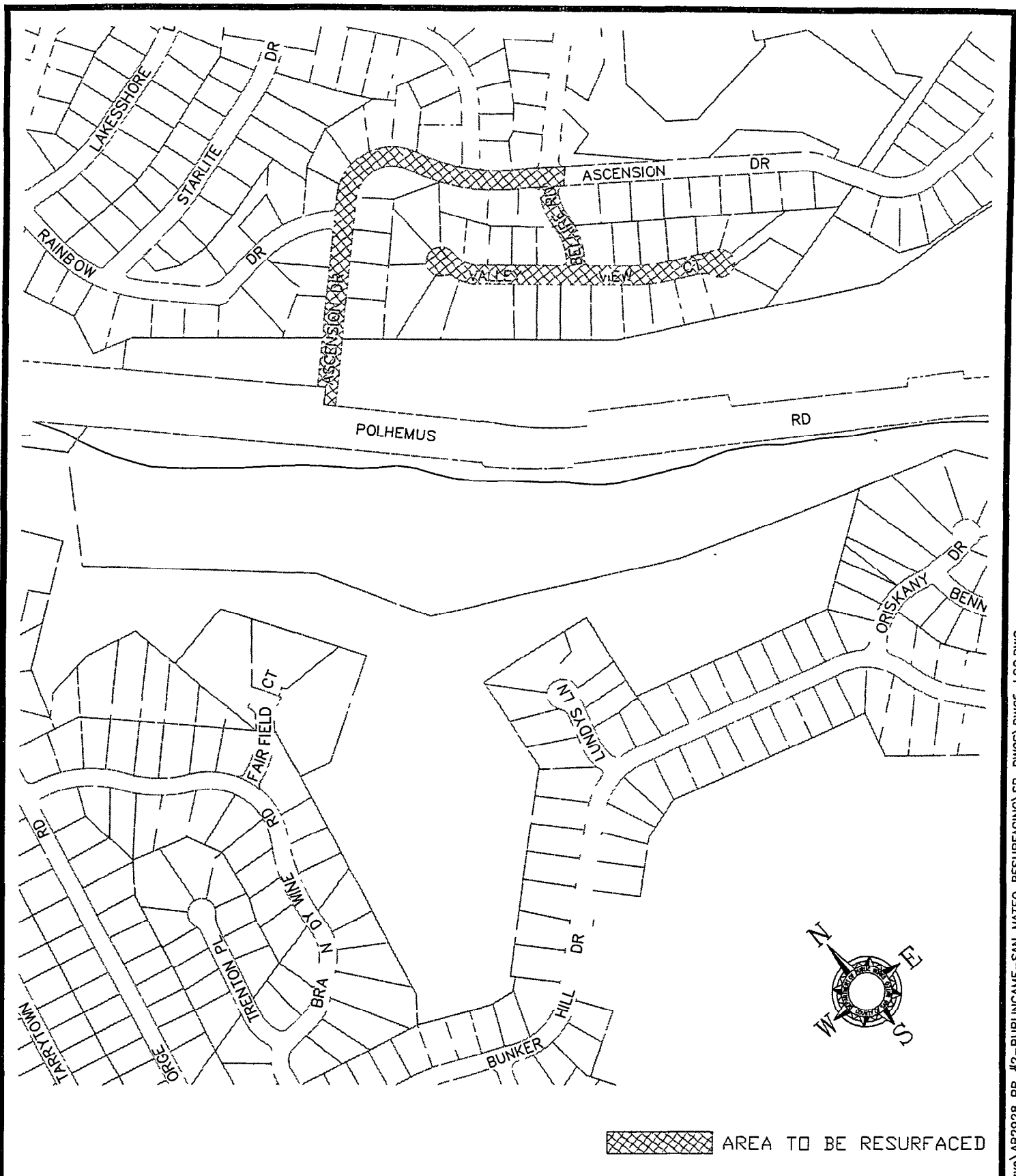
**BURLINGAME/SAN MATEO
