RECOMMENDATION

Approve an Appropriation Transfer Request (ATR) transferring \$281,605 from unanticipated revenue to the extra help and service and supply accounts within the Elections budget unit.

Background

On March 27, 2001, your Board approved Resolution No. 64312 authorizing the County Chief Elections Officer to render specified election services for the Town of Atherton, City of Millbrae, City of San Bruno, Belmont-Redwood Shores School District, and the Sequoia Union High School District Special Election to be held on Tuesday, June 5, 2001. Those entities will be billed for the entire cost of the elections, which costs are not included in the current fiscal year budget.

Discussion

Projected costs for the June 5, 2001 Special Election total \$281,605. This amount will cover anticipated expenditures for extra help, ballot printing, absentee voting, postage, polling place worker fees, and other miscellaneous expenses. The County will be reimbursed fully for these election expenditures. Funding will be coming from estimated revenue of \$281,605 from this election.

The purpose of this ATR is to transfer funds from unanticipated revenue to extra help and service and supply accounts within the Elections budget unit.

Fiscal Impact

There is no net county cost and no impact on the County General Fund.
