RESOLUTION COMMENDING AND HONORING

CAPTAIN PAUL B. FEYLING

WHEREAS it has come to the attention of the Board of Supervisors of the County of San Mateo, State of California that CAPTAIN PAUL FEYLING will be joined by his family, friends and colleagues on May 11, 2001 to celebrate his retirement from the San Mateo County Sheriff's Office, and

WHEREAS, in 1972, CAPTAIN PAUL FEYLING began his career in law enforcement as a Reserve Deputy Sheriff for the County of San Mateo. Realizing his calling, CAPTAIN PAUL FEYLING was hired as a full-time Deputy Sheriff in 1976. He served the citizens in East Palo Alto as a Patrol Deputy prior to finding his passion of Special Investigations, specifically narcotic enforcement, and

WHEREAS, in 1986, CAPTAIN PAUL FEYLING was promoted to Sheriff's Sergeant and once again his talents led him back to the field of narcotic enforcement as a Supervising Special Agent with the San Mateo County Narcotic Task Force; and

WHEREAS, in 1988, CAPTAIN PAUL FEYLING was promoted to Sheriff's Lieutenant. He worked a short time in the correctional system before moving to Personnel Services working to hire the best men and women to assuring the highest quality of service for the citizens of this county, and

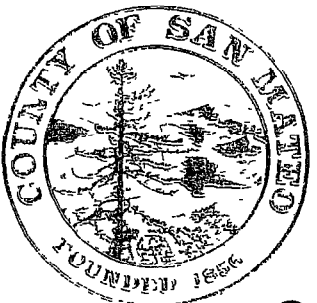
WHEREAS, in 1992, CAPTAIN PAUL FEYLING returned to the Narcotic Task Force, this time at the helm. He moved the Narcotic Task Force forward to become one of the best enforcement units in the state and was so recognized by several agencies. The Task Force received the prestigious Western States Information Network's Award of Excellence. In addition, CAPTAIN FEYLING established the Vehicle Theft Task Force which was one of the first of its kind in the state; and

WHEREAS, CAPTAIN PAUL FEYLING returned to the Sheriff's Office headquarters in 1995, where he was appointed to the rank of Sheriff's Captain. As Operations Captain, he went back out to the communities and opened three Sheriff's Substations in East Palo Alto, North Fair Oaks, and the coastside; and

WHEREAS, CAPTAIN PAUL FEYLING established two street crime teams responsible for reducing violent crimes and gang activity in San Mateo County. As part of his final assignment in Support Services, CAPTAIN FEYLING was responsible for hiring new recruits and ensuring the highest standards of pride, integrity and ethics for the Sheriff's Office.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the Board of Supervisors of the County of San Mateo, State of California, does hereby honor and commend CAPTAIN PAUL B. FEYLING for his unparalleled dedication and outstanding law enforcement service to the citizens of this county and wishes him many happy, healthy and successful years ahead.
