RECOMMENDATION

Adopt a resolution awarding and authorizing execution of a contract for the Slurry Sealing of Various Streets in the Ladera, Sequoia Tract, West Menlo, Menlo Oaks, Emerald Lake Hills, Palomar Park, San Mateo Highlands and Daly City Areas.

Previous Board Action

Adopted Resolution No. 64369 on April 10, 2001, adopting Plans and Specifications, determined prevailing wage scales and called for sealed proposals for the above-mentioned project.

Discussion

On Tuesday, May 8, 2001, bids were accepted for this project and subsequently referred to this office for checking and recommendation. The bids have been checked and the bid of:

at **\$89,150.62** was the lowest bid received.

The Engineer's estimate was \$102,000. A summary of the bids received is as follows:


We have reviewed the Contract documents and have determined that the Affirmative Action program submitted by **Bond Blacktop, Inc.** is in accordance with the current Affirmative Action Guidelines.

Fiscal Impact

The total estimated cost for construction and contingencies is \$98,000, which includes a ten percent (10%) contingency as the work is bid on a unit price basis (i.e., per square yard for slurry seal placed, per square yard for pavement repair areas, etc.). The contingency is used to pay the contractor for any additional material placed as the actual areas may vary somewhat from the original estimates.

There is no impact to the General Fund

A form of resolution has been approved by County Counsel.

**Resolution Awarding and Authorizing Execution of a Contract

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on April 10, 2001, adopt Resolution No 64369, which Resolution adopted the Plans and approved the Specifications, determined the prevailing wage scales and called for sealed proposals for the Slurry Sealing of Various Streets in the Ladera, Sequoia Tract, West Menlo, Menlo Oaks, Emerald Lake Hills, Palomar Park, San Mateo Highlands and Daly City Areas; and

WHEREAS, the Clerk of this Board of Supervisors did, in public on May 8, 2001, open and examine all sealed proposals that were received in the specified time for the doing of the work referred to in said Resolution No 64369, and

WHEREAS, this Board of Supervisors has caused an analysis of said sealed proposals to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

WHEREAS, the lowest responsible bid was submitted by **Bond Blacktop, Inc.**, in the amount of **Eighty-Nine Thousand One Hundred Fifty and 62/100 Dollars (\$ 89,150.62)** based on an estimate of the amount of work to be done

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. That it is to the best interest of the County of San Mateo to award the contract for the Slurry Sealing of Various Streets in the Ladera, Sequoia Tract, West Menlo, Menlo Oaks, Emerald Lake Hills, Palomar Park, San Mateo Highlands and Daly City Areas to:

2. That the County of San Mateo shall enter into a written contract with **Bond Blacktop, Inc.** for the doing of said work as required by the Plans and Specifications therefor adopted and approved by this Board of Supervisors, as hereinbefore mentioned, said Plans and Specifications being on file in the office of the Director of Public Works of the County of San Mateo

3. That the President of this Board of Supervisors shall be, and is hereby, authorized and directed, for and on behalf of the County of San Mateo, to enter into said written contract with **Bond Blacktop, Inc.** for doing of said work, as hereinbefore mentioned and to receive and approve the Faithful Performance Surety Bond and the Labor and Material Surety Bond required to be posted by the said Contractor with the County of San Mateo in connection

therewith

4. That all payments to the Contractor be in accordance with the Plans, Specifications, and other contract documents, based on the Director of Public Works written estimates of work actually done

5. That, Paragraph 4 above notwithstanding, aggregate payments to Contractor shall not exceed the sum of **Ninety-Eight Thousand and 00/100 Dollars (\$98,000.00)** without this Board's prior approval.

6. That the Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written contract.
