SUBJECT: Resolution Accepting Offer of Dedication of a Sewer Main to the Oak Knoll Sewer Maintenance District - Redwood City Area

RECOMMENDATION

Adopt a resolution accepting an offer of dedication of a sewer main constructed by Tersini Construction Company to the Oak Knoll Sewer Maintenance District (District)

Key Facts

- 1 Your Board, acting as the governing Board of the Oak Knoll Sewer Maintenance District, has the authority to accept facilities for operation and maintenance by the District
- 2 The Tersini Construction Company constructed approximately 139 linear feet of sewer main and appurtenances in the public right-of-way and has offered the facilities to the District.
- 3. The facilities were constructed to District standards and we are recommending that the District accept the facilities as they can be used to provide sewer service to other properties within the District

Discussion

The Tersini Construction Company constructed the sewer main in order to provide sewer services to properties at 390, 394, and 398 Upland Road in the Oak Knoll area The construction was done in accordance with plans reviewed and approved by Public Works.

Fiscal Impact

The cost of installing the sewer main was paid for by the Tersini Construction Company The cost of operation and maintenance of the new facilities, if accepted by the District, will be a District expense and will be funded through the sewer service charge levied on properties receiving sewer service from the District The current sewer service charge rate is \$275 per year per residential unit and includes the cost of maintaining the sewer mains as well as treatment costs There is no impact to the General Fund Honorable Board of Supervisors Subject: Resolution Accepting Offer of Dedication of a Sewer Main to the Oak Knoll Sewer Maintenance District - Redwood City Area May 4, 2001

Resolution Accepting Offer of Dedication for Construction of a Sewer Main Extension in the Oak Knoll Sewer Maintenance District

RESOLVED, by the Board of Supervisors, County of San Mateo, State of California, that WHEREAS, this Board of Supervisors, as the governing body of the Oak Knoll Sewer Maintenance District, a Sewer District of the County of San Mateo, State of California, hereinafter called District, 15 authorized to accept sewer system facilities constructed by private developers for operation and maintenance of said District; and

WHEREAS, Tersini Construction Company, hereinafter called Developer, has constructed approximately 139 L F. of 6" diameter sewer line, manholes and appurtenances connecting from the end of pipeline in the vicinity of 398 Upland Road and connecting to an existing Sewer Main located on Oak Knoll Drive, for the purposes of providing sewer system service to properties on Upland Road, and

WHEREAS, Developer has submitted a written offer of dedication of said sewer facilities for operation and maintenance by District, and upon acceptance by District, Developer relinquishes all further claim to said facilities, and WHEREAS, the Director of Public Works has recommended that said offer of dedication of sewer facilities be accepted by District, and

WHEREAS, this Board has considered the recommendation of the Director of Public Works
NOW, THEREFORE, BE IT RESOLVED, that said Offer of Dedication by Tersini Construction
Company of sanitary sewer facilities constructed by them in the vicinity of Upland Road and Oak Knoll
Drive is hereby accepted on behalf of the Oak Knoll Sewer Maintenance District, and said facilities shall
become a part of the District's facilities and shall be operated and maintained by said District


