RECOMMENDATION

Adopt a resolution adopting Plans and Specifications, determining prevailing wage scales, and calling for sealed proposals for the El Camino Box Culvert Installation in the Town of Colma and City of Daly City (Project).

Previous Board Action

- Modified the Colma Creek Flood Control Zone's adopted Flood Control Project which extended the project from Oak Avenue in South San Francisco to A Street in Daly City.
- Certified the Final Environmental Impact Report (EIR) and approved the Mitigation Monitoring and Reporting Plan for work in the Project area.
- Authorized the President of the Board to execute a Cooperative Agreement with Caltrans for sharing the costs of the Project.

Key Facts

This Project is part of an overall plan to provide a higher level of flood protection in the Colma Creek basin.

Discussion

This Project consists of constructing approximately 6,500 feet of a reinforced concrete box culvert in El Camino Real (Hwy 82) beginning with a connection to existing facilities near "A" Street in Daly City and tying into to recently constructed improvements in Mission Road in Colma. The Project will also divert additional flows away from the Colma Creek open channel at Mission Road into the culvert system to by pass the Treasure Island Mobile Home Park which has flooded in the past Staff has met individually with merchants and residents within the Project limits and we have incorporated procedures in the contract plans and specifications to minimize impacts and disruptions to businesses and residents during construction

WHEREAS, Plans and Specifications have been prepared and approved by the Director of Public Works for the El Camino Box Culvert Installation Project and said Plans and Specifications have been filed in the office of the Director of Public Works, and

WHEREAS, a schedule of prevailing wage scales for each craft or type of workman needed to execute this contract in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said Specifications

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows

- 1. The Plans and Specifications dated April 4, 2001, for the aforesaid project, are on file in the office of the Director of Public Works, to which reference is hereby made for further particulars, are hereby approved and are adopted as the Plans and Specifications to be adhered to in letting and performing the work under a contract for said improvements
- 2. The schedule of prevailing wages referred to in said Specifications has been determined to contain the general prevailing rates of wages in the locality in which said work is to be performed for each craft or type of workman needed to execute said contract
- 3. The Department of Public Works is authorized and directed to issue a call for sealed proposals to be received by the County Manager/Clerk of the Board of Supervisors of San Mateo County, on or before 2:00 p.m. Tuesday, June 12, 2001, in the County Manager/Clerk of the Board of Supervisors' offices in the Hall of Justice and Records, 400 County Center, Redwood City, California. Said bids will then be publicly opened and declared in the County Manager/Clerk of the Board of Supervisors' offices.

The Department of Public Works is further directed to cause the Notice inviting sealed proposals to be published for <u>two (2)</u> times in the <u>Independent Newspaper</u>

<u>Group</u>, a newspaper printed and published in this County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Clerk of the Board of Supervisors.
