SUBJECT: Harbor Industrial Area Road Improvement Project, Federal Aid Project No. STPL-5935 (023) (County Project Nos. R4D01 & R6R01, F-36 [21]) - Belmont /San Carlos Area

RECOMMENDATION

Adopt a resolution adopting Plans and Specifications, determining prevailing wage scales, and calling for sealed proposals for the resurfacing of Elmer Street, Harbor Boulevard, Industrial Road, and Old County Road; and the reconstruction of O'Neill Avenue.

Previous Board Action

1. Authorized funding applications for eight (8) Federal Transportation Program (STP) Projects which included the Harbor Boulevard Resurfacing Project
2. Authorized the Director of Public Works to.
 - a) proceed with the preparation of plans and specifications for resurfacing type projects on various County roads utilizing funds pursuant to Assembly Bill 2928 (AB2928); and
 - b) execute agreements with cities, utility companies and special districts for work less than \$25,000 proposed to be done in conjunction with County road projects.

Key Facts

1. The proposed project is part of our overall program to preserve the County maintained road system.
2. The City of Belmont has requested that their portion of O'Neill Avenue be reconstructed as part of this project.
3. The Mid-Peninsula Water District and the Harbor Industrial Sewer Maintenance District have requested that adjusting their facilities to grade within the project limits be included in the proposed project

Discussion

The proposed project, totaling approximately 0.8 miles in length, consists of the repair of failed pavement areas, the installation of pavement reinforcing fabric, the installation of access ramps where needed to meet the ADA requirements, resurfacing of the roadways with asphalt concrete, and replacing the traffic striping and pavement markers within the limits shown on the attached location map.

This project qualifies for a Categorical Exemption pursuant to Section 15301 C of the Public Resources Code (California Environmental Quality Act [CEQA]), and a Notice of Exemption has been filed with the County Clerk Recorder as provided by County guidelines

Fiscal Impact

The estimated cost of construction is \$1,055,000, which is proposed to be financed as follows:

Federal Surface Transportation Program (STP) Fund	\$ 384,220.00
Harbor Industrial Sewer Maintenance District	\$ 7,350.00
Mid-Peninsula Water District	\$ 4,200.00
City of Belmont (Reconstruction of Portion of O'Neill Ave.)	\$ 42,000.00
Road Funds and AB2928 Transportation Funds	<u>\$ 617,230.00</u>
Total Estimated Cost	\$1,055,000.00

We will bring a form of agreement to your Board prior to recommending that a contract be awarded for the proposed project which provides that the County will be reimbursed for the City's work. Reimbursement for the cost of doing work for the two Districts will be covered by agreements executed by the Director as authorized by your Board

There is no impact to the General Fund.

A form of resolution has been approved by County Counsel.

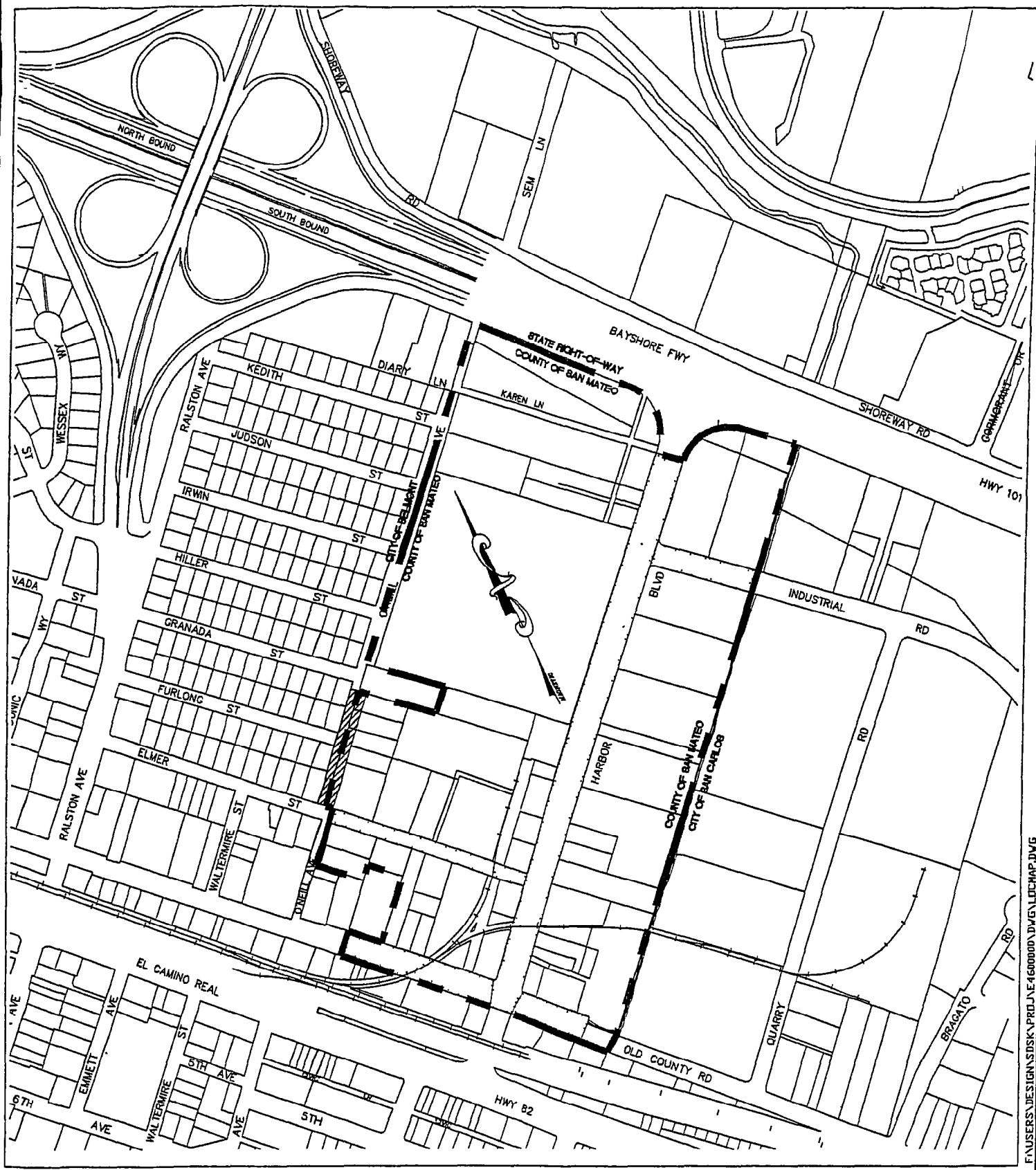

Determining Prevailing Wage Scales and Calling for Sealed Proposals for
the Harbor Industrial Area Road Improvement Project

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Plans and Specifications have been prepared and approved by the Director of Public Works for the resurfacing of Elmer Street, Harbor Boulevard, Industrial Road, and Old County Road and the reconstruction of O'Neill Avenue and said Plans and Specifications have been filed in the office of the Director of Public Works; and

WHEREAS, a schedule of prevailing wage scales for each craft or type of workman needed to execute this contract in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said Specifications

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows

1. The Plans and Specifications dated June 1, 2001 for the aforesaid project, are on file in the office of the Director of Public Works, to which reference is hereby made for further particulars, are hereby approved and are adopted as the Plans and Specifications to be adhered to in letting and performing the work under a contract for said improvements.

2. The schedule of prevailing wages referred to in said Specifications has been determined to contain the general prevailing rates of wages in the locality in which said work is to be performed for each craft or type of workman needed to execute said contract

3. The Department of Public Works is authorized and directed to issue a call for sealed proposals to be received by the County Manager / Clerk of the Board of Supervisors of San Mateo County, on or before 2:00 p.m., Tuesday, July 3, 2001, in the County Manager/ Clerk of the Board of Supervisors' offices in the Hall of Justice and Records, 400 County Center, Redwood City, California. Said bids will then be publicly opened and declared in the County Manager / Clerk of the Board of Supervisor's offices

The Department of Public Works is further directed to cause the Notice inviting sealed proposals to be published for two (2) times in the San Mateo County Times, a newspaper printed and published in this County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Clerk of the Board of Supervisors
