RECOMMENDATION

Adopt a resolution awarding and authorizing execution of a contract for the construction of ten (10) shade structures at Huddart Park.

Previous Board Action

Adopted Resolution No. 64478 on May 22, 2001, adopting Plans and Specifications, determining prevailing wage scales, and calling for sealed proposals for the above referenced project.

Discussion

On June 12, 2001, bids were accepted for this project and subsequently referred to this office for checking and recommendation. The bids have been checked and the bid of:

Bridger Construction 2995 Woodside Road #400 Woodside, CA 94062

at **\$91,500** was the lowest bid received. The Engineer's estimate was \$106,000. A summary of the bids received is as follows:

Resolution Awarding and Authorizing Execution of a Contract for Construction of Ten (10) Shade Structures at Huddart Park

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on May 22, 2001, adopt Resolution No. 64478, which Resolution adopted the Plans and approved the Specifications, determined the prevailing wage scales and called for sealed proposals for the construction of ten (10) shade structures at Huddart Park; and

WHEREAS, the Clerk of this Board of Supervisors did, in public on June 12, 2001, open and examine all sealed proposals that were received in the specified time for the doing of the work referred to in said Resolution No. 64478; and

WHEREAS, this Board of Supervisors has caused an analysis of said sealed proposals to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and WHEREAS, the lowest responsible bid was submitted by Bridger Construction, in the amount of Ninety-One Thousand Five Hundred and 00/100 Dollars (\$91,500.00) based on an estimate of the amount of work to be done:

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1.. That it is to the best interest of the County of San Mateo to award the contract for the construction of ten (10) shade structures at Huddart Park to:

Bridger Construction 2995 Woodside Road #400 Woodside, CA 94062

2. That the County of San Mateo shall enter into a written contract with Bridger Construction for the doing of said work as required by the Plans and Specifications therefore adopted and approved by this Board of Supervisors, as hereinbefore mentioned, said Plans and Specifications being on file in the office of the Director of Public Works of the County of San Mateo.

3. That the President of this Board of Supervisors shall be, and is hereby, authorized and directed, for and on behalf of the County of San Mateo, to enter into said written contract with **Bridger Construction** for doing of said work, as hereinbefore mentioned and to receive and approve the Faithful Performance Surety Bond and the Labor and Material Surety Bond required to be posted by the said Contractor with the County of San Mateo in connection therewith.

4. That all payments to the Contractor be in accordance with the Plans, Specifications, and other contract documents, based on the Director of Parks and Recreation's written estimates of work actually done.

5. That, Paragraph 4 above notwithstanding, aggregate payments to Contractor shall not exceed the sum of **One Hundred One Thousand and 00/100 Dollars** (\$101,000) without this Board's prior approval.

6. That the Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written contract.
