Recommendation

Adopt a Resolution authorizing the Board President, acting for the Governing Board of the District, to execute and record Certificates of Acceptance of any grants or deeds of real property as required to complete the dissolution of the District.

Background

Acting as the County Board of Supervisors in connection with the dissolution of the District, this Board authorized the transfer certain real property to the District.

Discussion

Government Code Section 27281 provides that, in order for a deed or grant of real property to a government agency to be accepted for recordation, the agency must authorize the acceptance of the property by certificate or resolution. Authorizing the Board President, acting for the Governing Board of the District, to execute a Certificate of Acceptance is an administrative action needed to record the transfers previously authorized.
