#### SUBJECT: Approval of Resolution Authorizing the Donation of Cell Phones

#### Recommendation

Adopt a resolution authorizing the donation of surplus cell phones to the CALL TO PROTECT program.

#### **Background**

Employee and Public Services, in its role as the Surplus Property Agent for the County, has received approximately 100 older model cell phones from Departments as surplus property. There is presently an inventory of 98 phones, with an expectation of receiving a small number of additional phones during this fiscal year.

The phones have been offered to the general public for \$3 to \$5 each at our monthly surplus property sales, but in the last six months we have sold only a few. The primary reason for the low sales is that these phones do not have any of the coveted features found on newer cell phones.

These cell phones are valuable, however, to the programs and agencies that protect victims of domestic violence. In conjunction with the Wireless Foundation, Motorola, and the National Coalition Against Domestic Violence, donated cell phones are refurbished and programmed to dial 911 and limited non-emergency numbers, offering a first line of security to victims of domestic violence.

#### **Discussion**

The County recently initiated a program encouraging members of the public to donate old cell phones to the County's Public Safety Communication Office. The phones are then distributed to the appropriate domestic violence agencies in conjunction with San Mateo County Law Enforcement and Fire Agencies. Since there is a very limited demand for these phones for general use and we have not been able to sell them, we recommend that they be donated to this program.

#### **Fiscal Impact**

There is no fiscal impact since we do not anticipate being able to sell these phones at our surplus property sales.
