### **Recommendation:**

Adopt a Resolution authorizing the Sheriff's Office to host the 2<sup>nd</sup> Annual Festival Cultural de la Middlefield, with funding up to \$10,000 provided by Peninsula Community Foundation, Community Alliance to Reclaim Our Neighborhood (CARON) and 21<sup>st</sup> Century grants.

## Backaround

The County of San Mateo Sheriff's Office was awarded the Peninsula Community Foundation CARON and 21st Century grants in May and September 2000. A portion of these funds are to be used to coordinate and recruit community based organizations to provide expanded learning and recreational activities for children and community members with the greatest needs in North Fair Oaks and promote a better relationship between North Fair Oaks residents and the Sheriff's Deputies who serve the area.

### Discussion

In celebration of the many positive community changes that have been taking place in the North Fair Oaks area, the Alliance, in association with the San Mateo County Sheriff's Office, will be hosting the 2<sup>nd</sup> Annual The festival will take place on "Festival Cultural de la Middlefield". Sunday, August 5, 2001 from 10:00 a.m. to 6:30 p.m. The central purpose of the festival is to engage community members in ongoing Alliance efforts to improve community safety and quality of life, provide positive community role models, and to promote the cultural diversity and economic contributions of the North Fair Oaks community.

The event is open to the public and participation of adjoining South County residents is encouraged. Attendance of approximately 8,000 to 10,000 North Fairs residents and neighbors throughout the course of the day is anticipated. Those who attend will be able to enjoy local cuisine, displays of arts and crafts, children's booths and games, cultural folkloric, tongan and samba dances, walkathon, mariachis, and much more. Educational booths will also be provided.

#### Fiscal Impact

The Sheriff's Office will contract with Special Events to provide booths, a stage and an art exhibit canopy. Costs are not to exceed \$10,000. The contract will be fully funded by the Peninsula Community Foundation and 21<sup>st</sup> Century grants. There will be no net County cost.

## The Second Middlefield Cultural Festival Revitalizing the North Fair Oaks community south of Redwood City

The Latino Community Alliance (LCA) and the San Mateo Sheriff's Office are hosting the <u>2nd</u> <u>Middlefield Cultural Festival in North Fair Oaks south of Redwood City on Sunday, August 5,</u> <u>2001 form10 am to 6:30 PM</u>. Middlefield Road will be closed to street traffic from 5<sup>th</sup> to 2<sup>nd</sup> Avenue, and a detour will be in force.

On August 5, Middlefield Road will be dressed up in colorful banners to welcome its approximately 20,000 guests with live music, Mexican and Pacific Islander food, and displays of arts and crafts. For the kids, there will be clowns and mimes, face and fingernail painting, and lots of fun games. The purpose of the festival is to celebrate the cultural diversity of North Fair Oaks, to revitalize the community, promote local business, and to provide information about community resources. Proceeds will be used to finance next year's event and to promote Latino art and culture among youth. Salvador Lara, the President of the LCA says, "The Festival is an opportunity for residents to come out and meet our neighbors. Most of us work long hours and rarely do we get to chat with them and develop friendships." He further adds, "I own a small business, the Golden Glaze Bakery, so the festival is a great opportunity to promote it."

The organization is the result of the Community Alliance to Reclaim Our Neighborhood Grant awarded to San Mateo County Sheriff's Office by the Peninsula Community Foundation in February 1999. According to Sheriff Don Horsley, "Our department has made a long term commitment to North Fair Oaks. The planning of the Middlefield Cultural Festival is a great opportunity for our staff to develop strong relations with the residents of North Fair Oaks."

RESOLVED, by the San Mateo County Board of Supervisors, County of San Mateo, State of California, that

WHERAS, the Board of Supervisors may authorize the hosting of a community event for the gereral benefit of the community and the public, at the request of the County department; and

WHEREAS, the County of San Mateo Sheriff's Office was awarded the Peninsula Community Foundation (CARON) and 21<sup>st</sup> Century grants in May and September 2000;
