#### RECOMMENDATION

Approve an Appropriation Transfer Request (ATR) in the amount of \$690,000 from the Micrographic Conversion-Unanticipated Revenue account to the Contract Special Program Services account and within the Assessor-County Clerk-Recorder's budget unit.

## Background/Discussion

On July 24, 2001, this honorable Board adopted a resolution authorizing an agreement with Deloitte & Touche, LLP, to serve as project manager of an electronic recording pilot project for the Assessor-County Clerk-Recorder. This project will encompass the development and implementation of an electronic signature and recordation system that will permit the electronic recordation of property reconveyances and tax liens. The agreement covers the period of July 24, 2001 through December 31, 2001 and is in an amount not to exceed \$690,000.

The July 24<sup>th</sup> Board item should have also included an ATR in the amount of \$690,000. this ATR was inadvertently omitted from the Board memo, an ATR will now need to be processed to pay the fees of Deloitte & Touche to provide project management, software development, and training services.

### Fiscal Impact

There will be no Net County Cost. Funding will come from existing funds in the Recorder's Modernization Trust Fund
