Continuation of Contracts

RECOMMENDATION

Adopt a resolution authorizing the Controller to continue payments on contracts from October 1, 2001 through December 31, 2001.

Summary

Health Services had a number of contracts for services that were placed on the continuing resolution that was approved by your board on June 26th of this year. Some of those contracts, listed in Attachment A, have not yet been renewed or extended. Those that will require your approval, along with the reasons for their delay, are listed below.

Alameda County-Regional Neuro-Behavioral Care Program and Santa Clara County are included due to delays with approval of the agreements by the vendors. There have been difficulties negotiating agreements with California Emergency Physicians, Crestwood Hospital, Health Maintenance Systems, Youth and Family Assistance, and the Veterans Administration. The agreements with the San Mateo County Health Center Foundation, Quest Diagnostics, and North Peninsula Family Alternatives are all the process of being completed.

To ensure continued provision of service during this period, it is necessary to authorize the Controller to continue to make payments to these contractors at the existing rate through December 31, 2001. This resolution allows contractors to meet their commitments in a timely fashion and will allow the divisions time needed to complete negotiations. This resolution requires that all terms and conditions of the existing agreements be met.

Fiscal Impact

Funds for the annual cost of all contracts have been included in the Health Services' 2001-02 recommended budget.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board authorizes the Controller to continue payments through December 31, 2001, on said Agreements for and on behalf of the County of San Mateo, subject to the contractors' continued compliance with all terms and conditions of its most recent and previous agreement with the County with the exception of the fiscal terms provisions. Said payments are to be in the amounts authorized by the Director of Health Services.
