SUBJECT: Sanitary Sewer Main Improvements - Fair Oaks Sewer Maintenance District – Redwood City/Town of Atherton Area (Projects No. SF401 and SF501, F-36 [373])

RECOMMENDATION

Acting as the governing Board of the Fair Oaks Sewer Maintenance District, adopt a resolution awarding and authorizing execution of a contract for the Improvement of Sanitary Sewer Mains on Bay Road between Charter Street and Barron Avenue, Selby Lane between Nimitz Avenue and Selby Lane, Himmel Avenue between Nimitz Avenue and Country Lane, and Country Lane.

Previous Board Action

1. Adopted Resolution No. 64714 on August 21, 2001, approving Plans and Specifications, determined prevailing wage scales and calling for sealed proposals for the above-mentioned project.
2. Authorized the Director of Public Works to execute agreements with cities, utility companies and special districts for work less than \$50,000 proposed to be done in conjunction with County improvement projects.

Discussion

On Tuesday, September 18, 2001, bids were accepted for this project and subsequently referred to this office for checking and recommendation. The bids have been checked and the bid of:

at \$1,454,970 was the lowest bid received.

The Engineer's estimate was \$1,825,000. A summary of the bids received is as follows:


Fiscal Impact

The total estimated construction cost for this project is \$1,600,000 which includes a ten percent (10%) contingency, as the work is bid on a unit price basis (i.e., per linear foot of pipe, per ton of asphalt concrete, per each for sanitary sewer lateral connections, etc.). The contingency is used to pay the contractor for any additional units of items used, as the actual costs will be based on the unit weight of the material or the tolerances associated with the placement of material, the actual length of pipe placed, actual number of service connections made, and other unknown or unforeseen work that may be required. Funding for the project will be financed as follows:

<u>California Water Service Company</u>	<u>\$ 1,000.00</u>
TOTAL	\$ 1,454,970.00

There is no impact to the General Fund.

A form of resolution has been approved by County Counsel. The Director of Public Works will execute the agreement with the California Water Service Company as authorized by your Board if the resolution awarding the project is approved.

(Projects No. SF401 and SF501, F-36 [373])**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, acting as the governing Board of the Fair Oaks Sewer Maintenance District, that

WHEREAS, this Board of Supervisors did, on August 21, 2001, adopt Resolution No. 64714, which Resolution adopted the Plans and approved the Specifications, determined the prevailing wage scales and called for sealed proposals for the Improvement of Sanitary Sewer Mains on Bay Road between Charter Street and Barron Avenue, Selby Lane between Nimitz Avenue and Selby Lane, Himmel Avenue between Nimitz Avenue and Country Lane, and Country Lane in the Redwood City and Town of Atherton Areas; and

WHEREAS, the Clerk of this Board of Supervisors did, in public on September 18, 2001, open and examine all sealed proposals that were received in the specified time for the doing of the work referred to in said Resolution No. 64714; and

WHEREAS, this Board of Supervisors has caused an analysis of said sealed proposals to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

WHEREAS, the lowest responsible bid was submitted by **Shaw Pipeline, Inc.**, in the amount of **One Million Four Hundred Fifty-Four Thousand Nine Hundred Seventy and No/100 Dollars (\$1,454,970.00)** based on an estimate of the amount of work to be done:

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. That it is in the best interest of the County of San Mateo to award the contract for the Improvement of Sanitary Sewer Mains on Bay Road, Selby Lane, and Country Lane to:

**Shaw Pipeline, Inc.
5244 Mission Street
San Francisco, CA 94112**

2. That the County of San Mateo shall enter into a written contract with **Shaw Pipeline, Inc.** for the doing of said work as required by the Plans and Specifications therefor adopted and approved by this Board of Supervisors, as hereinbefore mentioned, said Plans and Specifications being on file in the office of the Director of Public Works of the County of San Mateo.

3. That the President of this Board of Supervisors shall be, and is hereby, authorized and directed, for and on behalf of the County of San Mateo, to enter into said written contract with **Shaw Pipeline, Inc.** for doing of said work, as hereinbefore mentioned and to receive and approve the Faithful Performance Surety Bond and the Labor and Material Surety Bond required to be posted by the said Contractor with the County of San Mateo in connection therewith.

4. That all payments to the Contractor be in accordance with the Plans, Specifications, and other contract documents, based on the Director of Public Works' written estimates of work actually done.

5. That, Paragraph 4 above notwithstanding, aggregate payments to Contractor shall not exceed the sum of **One Million Six Hundred Thousand and No/100 Dollars (\$1,600,000.00)** without this Board's prior approval.

6. That the Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written contract.
