**RECOMMENDATION**


Adopt an Ordinance establishing a twenty (20)-minute limited parking zone on Avenue Portola, County Road No. 916.

**Discussion**

Residents of the El Granada Area have requested that a limited parking zone fronting the El Granada Post Office be established to allow for short term parking of patrons doing business at the post office.

We are recommending the installation of four twenty (20)-minute spaces fronting the Post Office. We do not believe the proposed limited parking spaces will impact the overall parking in the area as there is available on-street parking on both sides of Avenue Portola. In addition the Post Office has 16 on-site spaces designated for patron parking.

A form of Ordinance authorizing the installation of the limited parking zone at this location has been approved by County Counsel.

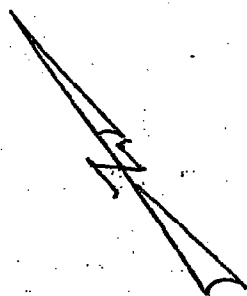

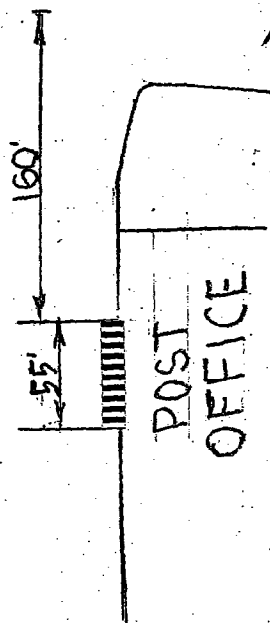

**An Ordinance Adding Section 7.24.840 to the  
San Mateo County Ordinance Code  
Establishing a Twenty (20) Minute Limited Parking Zone  
on a Portion of Avenue Portola in the El Granada Area**

The Board of Supervisors of the County of San Mateo, State of California, **ORDAINS** as follows:

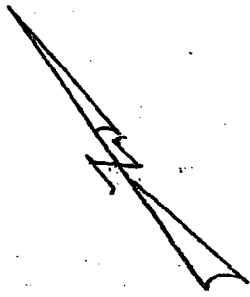
**SECTION 1.** Section 7.24.840 is hereby amended and added to the San Mateo County Ordinance Code to read as follows:

**SECTION 7.24.840 PORTOLA AVENUE, COUNTY ROAD NO. 916.**

A twenty (20) minute limited parking zone on the southerly side of Avenue Portola, beginning at a point 160 westerly of the centerline intersection with Avenue Alhambra, then continuing to a point 215 feet westerly of the said intersection for a total of 55 feet.

**SECTION 2.** This Ordinance shall be effective thirty (30) days from the passage date thereof.

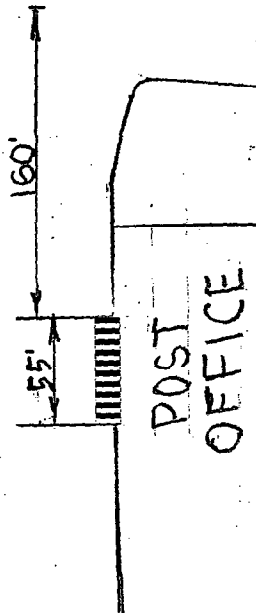
