RECOMMENDATION

Adopt a resolution approving the Disadvantaged Business Enterprise Program Annual Overall Goal for Federal Fiscal Year 2002.

Previous Board Action

Adopted Resolution No. 64159 on December 19, 2000, approving the Disadvantaged Business Enterprise Program for Federal Fiscal Year 2001.

Key Facts

- 1. All agencies wishing to receive Federal-aid transportation funds through the State of California, Department of Transportation must have a Disadvantaged Business Enterprise (DBE) Program in accordance with Title 49 of the Code of Federal Regulations (CFR), Part 26, beginning with Federal Fiscal Year 2001.
- 2. New Program goals must be established for each Federal fiscal year.
- 3. The County's draft DBE Program for Federal Fiscal Year 2002 has been approved by the State of California, Department of Transportation (DOT), Office of Local Programs. A public notice was published on August 28, 2001, setting a document review period of 30 days and a public comment period of 45 days from the date of publication. No comments have been received.
- 4. The approved DBE program will remain in effect until Federal Fiscal Year 2002/2003 (begins October 1, 2002).

Discussion

Title 49 of the CFR, Part 26, seeks to achieve several objectives to:

- a) ensure nondiscrimination in the award and administration of DOT-assisted contracts in an agency's highway, transit, and airport financial assistance programs;
- b) create a level playing field on which DBE's can compete fairly for DOT-assisted contracts;
- c) ensure that the agency's DBE program is narrowly tailored in accordance with applicable law;
- d) ensure that only firms that fully meet the eligibility standards are permitted to participate as DBE's;
- e) help remove barriers to the participation of DBE's in DOT -assisted contracts;
- f) assist the development of firms that can compete successfully in the market place outside the DBE program; and
- g) provide appropriate flexibility to recipients of Federal financial assistance in establishing and providing opportunities for DBEs.

The goal of the County's DBE Program for Federal Fiscal Year 2002 is to provide 6.2% of federally financed contracts to DBE contractors. DBE contractors are defined as for-profit small business concerns that are at least 51% owned and controlled by one or more socially and economically disadvantaged individuals. The management and daily business operations must also be controlled by one or more such individuals. These individuals must be citizens of the United States and (1) any individual who a recipient finds to be a socially and economically disadvantaged by the Small Business Administration.

The specific program is "exempted" from the provisions of Proposition 209 (California Constitution, Article 1, Section 31) as being an "action...taken to establish or maintain eligibility for any federal program, where ineligibility would result in loss of federal funds to the State".

The County of San Mateo California submits our annual overall goal information and notice of change of DBE Liaison Officer for your review and comment. Data for eight federal funded projects was used in the development of the DBE goal.
