Continuing resolution for AIDS Program Contracts

#### RECOMMENDATION

Adopt a resolution authorizing the Controller to continue payments on AIDS Program (SMCAP) Services contracts from March 1, 2002 through June 30, 2002.

#### Background

Your Board approved contracts for The AIDS Community Research Consortium (ACRC) HIV Food Program, Community Dental Care (CDC), the Mental Health Association of San Mateo County (MHA) HIV Housing Program and the Service League (SL) HIV Transitional Housing Program with terms ending February 28, 2002. All of these contracts are funded primarily by the Ryan White CARE Act, Title I funds (CARE) and/or by Housing Opportunities for Persons with AIDS (HOPWA). The award of HOPWA funds comes through the San Francisco Redevelopment Agency and CARE funds are contracted to SMCAP by the San Francisco Department of Public Health, AIDS Office.

#### Discussion

The appropriation for the Health and Human Resources Agency of the federal government was not passed until late in December of 2001. As a result, San Francisco has not yet received notice as to the amount of either the HOPWA or CARE awards. Therefore, SMCAP has not yet been notified as to its contract amount for the upcoming year. It is clear, however, that the awards will be continued. Because it is important for the services to continue and because it is not prudent to enter into a final agreement with the above named agencies until SMCAP has received award notification, a continuing resolution is requested at this time.

#### Term and Fiscal Impact

The term of the continuing resolution is from March 1, 2002 through June 30, 2002. There is no net county cost.

Said payments are to be in the amounts authorized by the Director of Health Services.
