

AMENDMENT NUMBER 1 TO THE AGREEMENT

THIS AGREEMENT, entered into this 19th day of March 2002 by and between the INFORMATION SERVICES DEPARTMENT OF THE COUNTY OF SAN MATEO, hereinafter called "County" and Bipin Bedi hereinafter called "Contractor",

WITNESSETH:

WHEREAS, on September 13, 2001, the parties hereto entered into agreement 18000-02-C096 (hereinafter referred to as the "Original Agreement") for the programming support for implementation of various projects within the County's Criminal Justice Information Systems (CJIS) by Contractor to County as set forth in that Original Agreement; and

WHEREAS, it is now the mutual desire and intent of the parties hereto to amend and clarify that Original Agreement;

NOW THEREFORE, IT IS HEREBY AGREED between the parties that the Original Agreement is amended and modified as follows:

2. **Contract Term**

The contract term shall be extended until August 30, 2002.

NOW THEREFORE, IT IS HEREBY AGREED between the parties that Exhibit "A" to the Original Agreement is amended and modified as follows:

I. **Description of Services to be Performed by the Contractor**

Contractor Bipin Bedi will provide Programmer/Analyst services to County in the form of programming support and technical services for the implementation of various projects within the County's Criminal Information Justice Systems (CJIS). Under the general direction of the

Business Systems' Deputy Director and Project Managers, he will provide the following types of services on projects as determined by the Business Systems' Deputy Director:

- Programming
- Unit and String Testing
- Software Installation
- System Testing
- Create and Maintain Program and System Documentation
- Other systems analysis/programming tasks as required

The methods and techniques used to provide services to the County are within the Contractor's discretion, but subject to County Information Services Department's technology policies, guidelines, and requirements. The amount of time, specific hours, and location of the performance of Contractor's services is also left to the Contractor's discretion provided that the amount of time expended is reasonable and Contractor coordinates with County departments as needed.

II. Amount and Method of Payment

The Contractor shall be paid at the rate of \$65.00 per hour. In no event shall total payment for services under this Agreement exceed in an amount of \$128,000.

NOW THEREFORE, IT IS HEREBY AGREED between the parties that :

This amendment and modification is hereby incorporated and made part of the Original Agreement and subject to all provisions therein. In the event of a conflict between the terms, conditions, or specifications set forth herein and those in the Original Agreement and/or Exhibit "A" attached thereto, the terms, conditions, or specifications set forth herein shall prevail. All other prices, terms and conditions of the agreement remain unchanged.


