(DALY CITY PENINSULA PARTNERSHIP COLLABORATIVE)

THIS FIRST AMENDMENT TO THE AGREEMENT, entered into on this day _____ of _____ 2002, by and between the COUNTY OF SAN MATEO, hereinafter-called "County", and the CITY OF DALY CITY hereinafter called "City"; JEFFERSON ELEMENTARY SCHOOLDISTRICT, BAYSHORE SCHOOL DISTRICT, SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT AND BRISBANE ELEMENTARY SCHOOL DISTRICT; all of which entities are referred to collectively as "the Parties".

W I T N E S S E T H:

WHEREAS, the Daly City Peninsula Partnership Collaborative was formed in 1995 with the mission to promote and facilitate collaborative efforts to ensure young children and their families have access to the health education and social services as needed to be successful in school and in life; and

WHEREAS, it is necessary and desirable that the parties enter into an agreement to establish a collaborative effort to support and expand the Daly City Peninsula Partnership Collaborative; and

WHEREAS, the parties now wish to amend the Agreement to add Cost of Business Increase (COBI) of 10% or \$15,000 to the first year of the Agreement and to extend the term of the Agreement from July 1, 2000 through June 30, 2002 to July 1, 2000 through June 30, 2004.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES AS FOLLOWS:

1. The following is added to Section 4 - Payments :

Payments In addition to the payment set forth herein:

For 2002/2004 fiscal year each of the parties shall contribute to the funding of the Daly City Peninsula Partnership Collaborative expansion services: County shall contribute the sum of FOUR HUNDRED THIRTY THOUSAND DOLLARS (\$430,000); the City of Daly City shall contribute the sum of ONE HUNDRED THIRTY NINE THOUSAND TWO HUNDRED TWENTY EIGHT DOLLARS (\$139,228); Bayshore School District shall contribute the sum of TEN THOUSAND DOLLARS (\$10,000) or equivalent services; Brisbane Elementary School District shall contribute the sum of TEN THOUSAND DOLLARS (\$10,000) or equivalent services; Jefferson Elementary School District shall contribute the sum of ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000) or equivalent services; and South San Francisco Unified School District shall contribute the sum of TWENTY THOUSAND DOLLARS (\$20,000) or equivalent services.

The funds for Fiscal Years (FY 2002-03 and FY 2003-04) shall be utilized according to the proposed FY 2002-04 Daly City Peninsula Partnership Collaborative Expansion Project budget which is attached to this amendment as Exhibit B-3 and Exhibit B-4.

The County shall pay a Cost of Business Increase of 10% or \$15,000 for FY 2000-01 upon receipt of an invoice from the City of Daly City on or before June 30, 2002.

2. Exhibit B – Payment Schedule is amended to add the following:

I.A.3. **Payment Schedule**

The County shall contribute to the funding of the Daly City Peninsula Partnership Collaborative expansion services for the FY 2002-04 budget as follows upon receipt of the invoice from the City of Daly City:

- C.1. Each of the participating school sites have designated funding and/or in-kind services in their FY 2002-04 budgets as follows:

- D.1 The funds and in-kind services contributed by each of the Parties will be utilized according to the FY 2002-04 Daly City Peninsula Partnership Collaborative Budget attached as Exhibit B-3 and Exhibit B-4.

3. Section 8 – “Non-discrimination” is amended to add the following new sub section D to:

D. **Equal Benefits Compliance** With respect to the provision of employee benefits, Contractor will comply with the County Ordinance which prohibits contractors from discriminating in the provision of employee benefits between an employee with a domestic partner and an employee with a spouse.

4. Section 14 – Term of the Agreement is amended to read as follows:

Term of the Agreement

Subject to compliance with the terms and conditions of this Agreement for The Daly City Peninsula Partnership Collaborative the term of this Agreement shall be from July 1, 2000 through June 30, 2004. This Agreement may be terminated by Parties, Director of Human Services or her designee at any time upon thirty (30) days' written notice to the other party. In the event that the Agreement is terminated. The County shall not be liable for any further payments.

5. Section 15 – Violation of Non-Discrimination provisions is added to the Agreement to read as follows:

Violation of Non-discrimination provisions.

Violation of the non-discrimination provisions of this Agreement shall be considered a breach of this Agreement and subject the Contractor to penalties, to be determined by the County Manager, including but not limited to

- i) termination of this Agreement;
- ii) disqualification of the Contractor from bidding on or being awarded a County contract for a period of up to 3 years;
- iii) liquidated damages of \$2,500 per violation;
- iv) imposition of other appropriate contractual and civil remedies and sanctions, as determined by the County Manager.

To effectuate the provisions of this paragraph, the County Manager shall have the authority to:

- i) examine Contractor's employment records with respect to compliance with this paragraph
- ii) set off all or any portion of the amount described in this paragraph against amounts due to Contractor under the Contract or any other Contractor between Contractor and County

6. All other terms and conditions of the agreement dated February 13, 2001 between the County and Contractor shall remain in full force and effect.

In response to the Declaration Form for Equal Benefits Compliance with the County of San Mateo I have attached an executed copy of the form and other documents.

RESOLUTION NO. 02-29

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DALY CITY
OF INTENT TO PROVIDE FOR EQUAL BENEFITS WHERE POSSIBLE
FOR EMPLOYEES WITH DOMESTIC PARTNER AS FOR EMPLOYEES WITH SPOUSE

A. The City of Daly City complies with both state and federal law, and as organizational policy, with the objective of non-discrimination based on marital status and/or sexual orientation; to and including policies for hiring, family and medical leave, and other local employment practices.

B. The City of Daly City seeks to investigate, consider, and where possible implement further policies and practices to promote non-discrimination in employee benefits.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Daly City that it issues this Notice of Intent to consider implementation of practices designed to provide Equal Benefits to full-time regular City employees, as between an employee with a spouse and an employee with a domestic partner, subject to the following considerations:

1. The actual cost of providing any particular benefit to a domestic partner of an employee shall not exceed that of providing the benefit to a spouse of an employee.

2. The City shall not be required re-negotiate existing agreements for employee health, welfare and benefit plans during the term of such plans if the ability to amend such existing plans without cost is not available.

3. The City cannot, through the exercise of reasonable measures, extend a particular benefit to domestic partners.
