# **RECOMMENDATION:**

Adopt a resolution in support of efforts to replace Peninsula Health Center.

## **BACKGROUND:**

Peninsula Medical Center is a vital component of the countywide system for providing healthcare to the residents of the County of San Mateo, and is a leading institution in our county. The State of California has enacted legislation which mandates increased seismic safety standards for hospitals, and it has been determined that Peninsula Medical Center could sustain significant damage in an earthquake, which could render the hospital inoperable. Peninsula Medical Center needs to be replaced in order to comply with the new state earthquake safety standards. Mills-Peninsula Health Services has committed to provide over \$350,000,000 to build a new, state of the art hospital.

# **DISCUSSION**:

The new Peninsula Medical Center will have a 24-hour, seven day a week full service state of the art emergency facility. It will cost nothing for the taxpayers of the County of San Mateo, because the new facility will be financed by Mills-Peninsula Health Services and Sutter Health Services, the not-for-profit network of which Mills-Peninsula is a part. Building the new hospital to replace the existing Peninsula Health Center will improve health care services for the residents of the County of San Mateo.

### **VISION ALIGNMENT:**

The resolution keeps the commitment of ensuring basic health and safety for all, and goal number 5, "residents have access to healthcare and preventive care." The resolution contributes to this commitment and goal by providing the County of San Mateo's support for a safe, state of the art health care facility.

### FISCAL IMPACT:

There is no fiscal impact.
