

**AGREEMENT FOR SERVICE BETWEEN
Redwood City School District
AND
The County of San Mateo**

This agreement is made on this 1st day of July 2001 through June 30, 2002 by and between the Redwood City Elementary School District (RCSD) and the County of San Mateo (CONTRACTOR).

WHEREAS, the RCSD desires mental health services for the Redwood City Family Centers

WHEREAS, the CONTRACTOR desires to provide mental health services for the RCSD, who serves as fiscal agent for the Redwood City Family Centers

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. SERVICES

The CONTRACTOR agrees to provide Psychiatric Social Workers to the RCSD in accordance with the terms and conditions of this agreement.

2. AMOUNT OF SERVICES

The CONTRACTOR agrees to provide the Psychiatric Social Workers for the amount of \$157,090:

1. 1 FTE Psychiatric Social Worker at Taft –	25%	\$20,490
2. 1 FTE Psychiatric Social Worker at Fair Oaks –	50%	\$40,980
3. 1 FTE Psychiatric Social Worker at Hoover –	50%	\$40,980
4. 1 FTE Psychiatric Social Worker at Hoover –	25%	\$20,490
5. 1 FTE Psychiatric Social Worker at Kennedy – (4 months)	50%	\$13,660
6. 1 FTE Psychiatric Social Worker at Preschool – (3 months)	100%	\$20,490

3. USE OF SUBCONTRACTORS

CONTRACTOR shall not assign this Agreement or any portion thereof to a third party without the prior written consent of the Redwood City School District.

4. INSURANCE

CONTRACTOR understands the RCSD does not provide liability, malpractice or workers compensation insurance for the CONTRACTOR. The CONTRACTOR is responsible for the maintenance of personal and professional insurance or self-insurance to provide protection for any claims arising out of service under this agreement. The CONTRACTOR assumes all liability for services provided under this contract. The CONTRACTOR will provide proof of insurance or self-insurance and will identify RCSD as an additional insured.

5. EQUAL EMPLOYMENT OPPORTUNITY

In connection with the performance of this agreement, the CONTRACTOR shall not discriminate against any employee or applicant for employment because of race, religion, color, sexual orientation, physical disability or national origin.

6. HOLD HARMLESS

Contractor shall indemnify and save harmless County, its officers, agents, employees, and servants from all claims, suits, or actions of every name, kind and description, brought for, on account of: (A) injuries to or death of any person, including Contractor, or (B) damage to any property of any kind whatsoever and to whomever belonging; or (C) any other loss or cost, including but not limited to, the concurrent active or passive negligence of County, its officers, agents, employees, or servants resulting from the performance of any work required of Contractor or payments made pursuant to this Agreement, provided that this shall not apply to injuries or damage for which the County has been found in a court of competent jurisdiction to be solely liable by reason of its own negligence or will misconduct.

The duty of Contractor to indemnify and save harmless as set forth herein, shall include the duty to defend as set forth in Section 2778 of the California Civil Code.

7. DISPUTE RESOLUTION

Should any dispute arise out of this agreement, the parties should meet in mediation and attempt to reach a resolution with the assistance of a mutually acceptable mediator. The costs of the mediator, if any, shall be paid by the District. If a mediated settlement is reached, neither party shall be the prevailing party for the purposes of this settlement. Neither party shall be permitted to file legal action without first meeting in mediation and making a good faith attempt to reach a mediated resolution.

8. COMPENSATION

The CONTRACTOR agrees to perform all of the services of this agreement for a total not to exceed \$157,090.

9. PAYMENT

CONTRACTOR shall submit one invoice for the full amount detailing the services performed during the billing period. RCSD shall pay invoice promptly within a period not to exceed 30 days of receipt of the invoice.






