**RESOLUTION CALLING AN ADVISORY ELECTION REGARDING  
THE EXTENSION OF THE BOUNDARIES OF THE MIDPENINSULA  
REGIONAL OPEN SPACE DISTRICT**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS** in 1998, the Midpeninsula Regional Open Space District placed an advisory measure on the ballot asking certain voters in San Mateo County as to whether the Midpeninsula Regional Open Space District should extend its boundary west of Skyline Boulevard to the San Mateo County Coast, from the southern boundary of Pacifica to the Santa Cruz County line and;

**WHEREAS**, the majority of voters voted in favor of the Midpeninsula Regional Open Space District's advisory measure; and

**WHEREAS**, the Midpeninsula Regional Open Space District has issued a draft environmental impact report containing alternative geographic annexation areas as a preliminary step in its application process to annex certain territory to the Midpeninsula Regional Open Space District to be considered by San Mateo County Local Agency Formation Commission; and

**WHEREAS**, the Pescadero Municipal Advisory Council is of the opinion that since the 1998 advisory election, much of the available "at risk" lands located in the south coast area have been protected as open space; and

**WHEREAS**, the Pescadero Municipal Advisory Council has requested the Board of Supervisors to place on the November 5, 2002 ballot, an advisory measure asking the voters

south of the City of Half Moon Bay and west of Skyline Boulevard if they want that territory, to the extent it is not currently a part of the District, to be included within the boundaries of the Midpeninsula Regional Open Space District; and

**WHEREAS**, Elections Code section 9603 authorizes the County to hold, at its discretion, an advisory election on any date on which that jurisdiction is currently permitted to hold a regular or special election for the purpose of allowing voters within the jurisdiction, or a portion thereof, to voice their opinions on substantive issues, or to indicate to the local legislative body approval or disapproval of the ballot proposal; and

**WHEREAS**, the Board of Supervisors has determined that the voters in those precincts and portions thereof, south of the City of Half Moon Bay to the Santa Cruz County line and west of Skyline Boulevard to the coast of San Mateo County, which are not already part of the Midpeninsula Regional Open Space District, should be presented with an advisory measure asking whether these areas should be included in the Midpeninsula Regional Open Space District;

**NOW THEREFORE, IT IS HEREBY RESOLVED** as follows:

1. The Board of Supervisors hereby submits the advisory measure set forth below in part 4, to the registered voters of the following precincts, and portions thereof, located within San Mateo County: unincorporated area of Half Moon Bay, precinct #3331-0, #3331-1, #3331-2 and #3331-3; portions of La Honda, precinct #3340-0, #3340-1, #3341-0, #3341-1, #3341-2, #3341-5 and #3341-6; Pescadero, full precincts #3350-0 and #3350-1; portions of San Gregorio, precinct #3360-0, #3360-1, #3360-2, #3360-9 and #3360-A; portions of the area known as Skyline, precinct #3370-0, #3370-C, #3370-D, #3371-0, #3371-3 and #3376-6.

2. The County Clerk shall publish a notice of this election, as required by general law, in a newspaper of general circulation published in the County of San Mateo.

3. (a) The Election shall be held and conducted, the returns canvassed, and the result declared in the same manner as provided by law for general elections.
- (b) The Election will be held on November 5, 2002, from the hour of 7:00 a.m. to the hour of 8:00 p.m., during which period of time the polls will remain continuously open. At 8:00 p.m., the polls will be closed, except as provided in section 14401 of the Elections Code.
- (c) The County Clerk shall prepare and mail to each eligible voter in the registered voters of the following precincts located within San Mateo County: unincorporated area of Half Moon Bay, precinct #3331-0, #3331-1, #3331-2 and #3331-3; portions of La Honda, precinct #3340-0, #3340-1, #3341-0, #3341-1, #3341-2, #3341-5 and #3341-6; Pescadero, full precincts #3350-0 and #3350-1; portions of San Gregorio, precinct #3360-0, #3360-1, #3360-2, #3360-9 and #3360-A; portions of the area known as Skyline, precinct #3370-0, #3370-C, #3370-D, #3371-0, #3371-3 and #3376-6, a sample ballot and a voter's information pamphlet containing the complete text of the advisory measure.
- (d) The County Clerk shall establish election precincts, designate the polling places, and provide election officers for each of the listed

precincts at the November 5, 2002, election in accordance with the election laws of the State of California.

- (e) The election on the advisory measure shall be consolidated with any and all other elections to be held on November 5, 2002.

4. The following advisory measure shall be submitted to the electorate located in the unincorporated area of Half Moon Bay, precinct #3331-0, #3331-1, #3331-2 and #3331-3; portions of La Honda, precinct #3340-0, #3340-1, #3341-0, #3341-1, #3341-2, #3341-5 and #3341-6; Pescadero, full precincts #3350-0 and #3350-1; portions of San Gregorio, precinct #3360-0, #3360-1, #3360-2, #3360-9 and #3360-A; portions of the area known as Skyline, precinct #3370-0, #3370-C, #3370-D, #3371-0, #3371-3 and #3376-6, on November 5, 2002:

**Advisory Vote Only**

“Shall the Midpeninsula Regional Open Space District extend its boundary to include territory not currently within the District which is generally described as west of Skyline Boulevard to the San Mateo County Coast and south of the City of Half Moon Bay to the Santa Cruz County line?”
