SUBJECT: Agreement with Child Care Coordinating Council (4Cs)

Recommendation

Adopt a Resolution authorizing execution of an Agreement with Child Care Coordinating Council (4Cs) in the amount of \$105,000. The term of the Agreement is October 1, 2002 through June 30, 2005.

Background

The Human Services Agency is the public agency designated to administer AB2994 the Child Abuse Prevention, Intervention and Treatment (CAPIT) and Community Based Family Resource and Support Programs.

The Children's Trust Fund, CAPIT and CBFRS funds are the County resources for the child abuse prevention and treatment programs and are included in the San Mateo County Three Year Plan. Children's Collaborative Action Team (CCAT) the San Mateo County Child Abuse Council is the designated AB2994 Child Abuse Trust Fund Commission for distribution of child abuse prevention funds and under the direction of the Office of Child Abuse Prevention (OCAP) developed the County Three Year Plan.

Discussion

The Human Services Agency has looked to the Family Resource Center model as a site to deliver child abuse prevention services. This service delivery model was included in the Request for Proposal (RFP) released by CCAT on March 6, 2002. The Child Care Coordinating Council successfully competed for Child Abuse Prevention/Intervention, "Warm Line", and Family Resource Center Services funds for this creative program and was awarded \$35,000 per year for three years.

Vision Alignment

The contract with the Child Care Coordinating Council keeps the commitment of: Providing equal access to educational opportunity and goal number 3: All children ages 0-5 years have access to child care/early learning opportunities that contribute to their entering kindergarten ready to succeed. The Child Care Coordinating Council contributes to this commitment and goal by providing case management services to preschool children who are identified for being at risk of abuse and neglect.

Fiscal Impact

The term of the Agreement is October 1, 2002 through June 30, 2005. The total obligation is \$105,000. This Agreement is 100% funded through birth certificate fees (AB2994), CAPIT funds, and CBFRS funds. There is no Net County Cost.
