
Appointment to the Emergency Medical Care Committee

On September 13, 1977, the Board of Supervisors adopted Resolution 37712 forming the Emergency Medical Care Committee. The duties also include establishing and monitoring emergency care guidelines; presenting recommendations to improve emergency care; and establishing and monitoring critical patient treatment and transfer guidelines.
