**Discussion:**

On September 13, 1977, the Board of Supervisors adopted Resolution 37712 forming the Emergency Medical Care Committee. The duties of the committee are to review annually each of the ambulance services operating within the county; ambulance services offered within the county; and first aid practices in the county. The duties also include establishing and monitoring emergency care guidelines; presenting recommendations to improve emergency care; and establishing and monitoring critical patient treatment and transfer guidelines.
