## RESOLUTION AUTHORIZING EXECUTION OF AGREEMENTS FOR HOUSING REHABILITATION SERVICES UNDER THE URBAN COUNTY'S COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR FEDERAL FISCAL YEARS 2003, 2004 & 2005 WITH THE CITIES OF ATHERTON, BELMONT, BRISBANE, BURLINGAME, COLMA, EAST PALO ALTO, FOSTER CITY, HALF MOON BAY, HILLSBOROUGH, MILLBRAE, PACIFICA, PORTOLA VALLEY, SAN BRUNO, SAN CARLOS AND WOODSIDE

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Housing and Community Development Act of 1974, Public Law 93-383, enacted August 22, 1974, and the Housing and Community Development Act of 1977, Public Law 95-128, enacted October 12, 1977, both provide for the distribution of federal funds through the process of community development block grants to eligible public entities; and

WHEREAS, Cooperation Agreements by and between Cities and the County are submitted establishing the formal relationship to be cooperative and co-participants in the Urban County Community Development Block Grant Program for federal fiscal years 2003, 2004 and 2005; and

WHEREAS, pursuant to the provisions of Section 51300 et seq of the Government Code, the Board of Supervisors of the County of San Mateo may contract with the City, and the City Council of the City may contract with the County for the performance of the City functions by the appropriate officers and employees of the County; and WHEREAS, the Cities desire the County to perform the Housing Rehabilitation Loan Program services hereinafter set forth for and on behalf of the Cities within the territorial limits of said respective Cities and the County is willing to perform such services; and

WHEREAS, the County and the Cities of Atherton, Belmont, Brisbane, Burlingame, Colma, East Palo Alto, Foster City, Half Moon Bay, Hillsborough, Millbrae, Pacifica, Portola Valley, San Bruno, San Carlos and Woodside agree that rehabilitation services shall be provided by the County in said Cities in accordance with the attached Agreements.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the President of this Board of Supervisors be, and is hereby authorized and directed to execute said Agreements for and on behalf of the County of San Mateo and the Clerk of this Board shall attest the President's signature thereto.
