RESOLUTION HONORING AND COMMENDING

WHEREAS, the SERVICE LEAGUE OF SAN MATEO COUNTY provides defendants in jury trials with appropriate clothes to wear in court; and

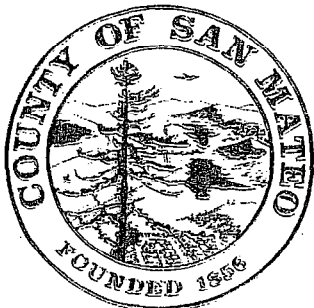

WHEREAS, the SERVICE LEAGUE OF SAN MATEO COUNTY provides women leaving women's correctional institutions with a residential alcohol and drug treatment facility at Hope House and men released from correctional facilities with a clean and sober shared housing facility and structured program at Freedom And Recovery (F.A.R.), and through Project Hope, substance abuse treatment at the three county homeless shelters,


