WHEREAS, CAPTAIN RICHARD R. WATSON was designated as the Project Manager in September of 2001 when construction began on the new joint police facility, shared with the BART Police Department, which became operational in September of 2003; and

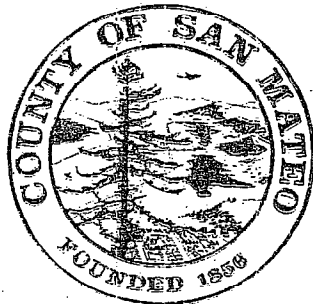
