**AMENDMENT TO SAN MATEO COUNTY MASTER RENTAL AGREEMENT
Copy Machines, Bid No. 1001, December, 1999**

This is an Amendment to the Copy Machine Master Rental Agreement, hereinafter called "Agreement" dated May 31, 2000 by and between San Mateo County, a political subdivision of the State of California, hereinafter called "County" and MBA of California, Inc., hereinafter called "Contractor/Vendor."

WITNESSETH

Whereas, the County awarded Contractor/Vendor a three year agreement to provide copy machines for all County departments per San Mateo County Board Resolution No. 63619; and

Whereas, said Agreement specified separate rental agreements for each machine supplied in accordance with a pricing schedule contained in Exhibit A of the Agreement; and

Whereas, said Agreement provided the County with the option of extending the contract for two additional years; and

Whereas, on July 30, 2001 the Contractor/Vendor executed Change Order No. 1 to the Agreement, acknowledging and agreeing to comply with the County's Equal Benefits Ordinance and updated non-discrimination requirements.

NOW, THEREFORE IT IS HEREBY AGREED by the parties as follows:

1. **Extension:** All individual agreements (Addendum A's) for individual copy machines under this Agreement are hereby extended for an additional two year term.
2. **Pricing:** The pricing schedule as contained in Exhibit A shall be reduced by ten (10%) percent for all machines (Machines A through J, inclusive) for the two additional years (years 4 and 5).

3. The following paragraphs will be added to the Agreement:

- 15. **Adjustments:** Due to the excessive number of copiers placed in the later part of 2000 and early part of 2001, the expiration date of some machines, at the request of the County, will be adjusted to less than a two year extension, to better allow the County to manage and maintain equipment, as well as implement an orderly rotation schedule.

- 16. **Cancellation of individual Addendum A's:** The County reserves the right to cancel individual copier agreements (Addendum A's) without cause on thirty (30) days notice. Nothing in this paragraph changes or modifies the County's additional right to terminate the entire Agreement, as set forth in Paragraph 7 of the original Master Agreement. Likewise, nothing herein changes or modifies Contractor/Vendor's obligations to service and supply said copy machines as contained throughout the original Master Agreement.

- 17. **Donation of individual machines:** At the expiration of the individual terms for each copy machine, Contractor/Vendor shall make a charitable donation of said copy machine(s) to San Mateo County for its surplus property program. Contractor/Vendor may, at its discretion, apply for a deduction on its federal, state, or local taxes, where applicable. The donation of individual copy machines to the County at the end of each copy machine's term shall be irrevocable whether or not MBA of California, Inc. is successful in obtaining any tax deductions.

4. **Remaining Terms and Conditions:** All other terms and conditions of the Agreement remain unchanged, and in full force and effect.
