SECOND AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

This Second Amendment of Agreement, dated for reference purposes, this ______ day of _______, 2003, is made by and between the County of San Mateo, hereinafter referred to as "County", and the City of Half Moon Bay, hereinafter referred to as "City", who mutually agree to the terms and conditions contained herein (the "Second Amendment").

1. This Second Amendment is entered into with reference to the following facts and objectives:

a. County and City entered into a Professional Services Agreement dated March 24, 1998, and amended September 14, 1999 (the "Amended Agreement") for right-of-way acquisition services to be performed by County in connection with the City's Highway 92/Main Street Improvement Project.

b. The Amended Agreement expired on June 30, 2001.

c. Due to the change in scope and construction limits, and increased complexity of the appraisal aspects of the Project, completion of the services under the Amended Agreement requires an extension of the term, an increase in the amount payable to County, and a modification of the scope of work set forth in the Amended Agreement.

d. The parties desire to further amend the Amended Agreement as set forth herein.

2. Section 5 of the Amended Agreement shall be amended to extend the termination date to June 30, 2005.

3. Section 7A of the Amended Agreement shall be amended to increase the amount of the maximum compensation under the agreement from One Hundred Eighty Six Thousand Nine Hundred Dollars (\$186,900) to Three Hundred Seven Thousand Two Hundred Forty Five Dollars and Thirteen Cents (\$307,245.17).

4. Appendixes "A" and "B" shall be amended to delete the Revised Parcel List for Appendix A and Appendix B and replaced with the attached Parcel List- Revision 2.

5. All other provisions of the Agreement shall remain unchanged and in full force and effect.
