

FIRST AMENDMENT TO THE HEALTHWORX GROUP AGREEMENT BETWEEN THE HEALTH PLAN OF SAN MATEO AND THE SAN MATEO COUNTY PUBLIC AUTHORITY

This Amendment, entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2003, by and between the San Mateo Health Commission, dba Health Plan of San Mateo (hereinafter called "PLAN") and the San Mateo County Public Authority (hereinafter called "Contract Holder");

W I T N E S S E T H :

WHEREAS, on June 10, 2003, the parties hereto entered into a Group Agreement for the Health Plan to administer the HealthWorx program for IHSS workers; and

WHEREAS, it is now the mutual desire and intent of the parties hereto to amend and clarify that Agreement:

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES THAT THESE AMENDMENTS ARE HEREBY INCORPORATED AND MADE A PART OF THE ORIGINAL AGREEMENT AND SUBJECT TO ALL PROVISIONS THEREOF, AND THE AGREEMENT IS HEREBY AMENDED AS FOLLOWS:**

**Change No. 1.**

The original sections 4.0, 4.1 and 4.1.1 are hereby deleted.

**Change No. 2.**

A new section 4.0 is hereby added to the agreement, to read as follows:

4.0 Term

The term of this Group Agreement shall be from August 1, 2002 through July 31, 2005.

**Change No. 3.**

Section 3.0 is hereby amended to read as follows:

3.0 Premiums for the Covered Benefits under this group agreement are as set forth in Attachment B, and any amendments thereto, which Attachment and amendments are fully incorporated herein by reference.

**Change No. 4.**

Attachment B is hereby amended to read as follows:

**Premium Schedule for 2003 – 2004  
(August 1, 2002 – July 31, 2004)\***

Premium .....195.31 per member/per month

**\* Pursuant to the procedures set forth in Section 3.1 of this Agreement, the Premium rates for the period of August 1, 2004 through July 31, 2005 shall be determined by negotiation of the parties, submission to the State Department of Health Services, and an amendment to this Attachment. It is expected that said process will be completed not later than July 31, 2004.**

IT IS HEREBY FURTHER AGREED BY THE PARTIES that all provisions of the original Agreement shall be binding on all the parties hereto.
