AGREEMENT FOR THE LOAN OF FUNDS TO COUNTY SERVICE AREA NO. 11 FROM THE COUNTY GENERAL FUND

This Agreement,	entered into this	_day of	, 2003 by and
between COUNTY SER	VICE AREA NO. 11 c	f the County of San Ma	nteo, State of California,
hereinafter called "CSA 1	1", and the COUNTY	OF SAN MATEO , Sta	te of California,
hereinafter called "COUN	ITY".		

WITNESSETH:

WHEREAS, Section 25210.9c et seq. of the Government Code of the State of California provides that a board of supervisors of a county may lend available funds to a county service area; and

WHEREAS, CSA 11 has been offered a grant from the United States Department of Agriculture (USDA) in the amount of \$135,000 to partially fund the construction of a new well to serve CSA 11; and

WHEREAS, it is estimated that an additional \$165,000 will be needed to fund the new well; and

WHEREAS, the USDA requires that a source of any additional funds as may be necessary to fund the well be identified as a condition of receiving the grant; and

WHEREAS, the USDA further requires that if the source of the funds is a loan, that the term of the loan be not less than 40 years and that interest be not more than five percent (5%) per annum; and

WHEREAS, it is necessary and desirable that the sum of \$165,000 be advanced to CSA 11.

NOW, THEREFORE, IT IS AGREED BY THE PARTIES HERETO as follows:

- 1. County agrees to lend CSA 11 the sum of \$165,000 for a period of not less than ten years. Said sum shall be lent from the County's General Fund.
- 2. Said loan shall automatically be extended up to three ten year periods if the loan plus interest is not repaid by the end of the first, second or third ten-year term.
- 3. CSA 11 agrees to pay interest on all funds owed County under terms of this Agreement at the rate equal to an annual interest rate of five percent (5%).
- 4. CSA 11 agrees that said advanced sums plus interest as provided herein shall be repaid to County on or before July 1, 2044.
