- 3. Section 4., **Payment Terms** is amended by adding the following:

A.4 For Grant Year Four, PHI/PPH agrees to provide funds to Grantee in the amount of \$150,000 for the performance of activities described in Exhibit D.

The first payment for Grant Year Four in the amount of \$100,000 is payable upon receipt of a fully-executed original of this amendment.

The second payment for Grant Year Four in the amount of \$50,000 is payable upon receipt and approval of the Final Progress and Financial Report in accordance with the provisions of Exhibit D.

All other terms and provisions of the agreement shall remain in full force and effect.
