WHEREAS, DUANE BOLTON served the Daly City Police Department in various capacities. working as a patrol officer, records supervisor, station supervisor, evidence technician and serving on the Police Athletic League Board of Directors for numerous years. He excelled as an officer and in 1985, was assigned to Field Officer Training School, where he learned to mentor and eventually share his knowledge with young recruits. DUANE BOLTON was eventually promoted to the position of Computer Systems Administrator, where he served until his retirement; and

WHEREAS, DUANE BOLTON received numerous Departmental commendations including praise for his extensive and thorough investigations, highlighting his numerous cases on auto theft and even one for rescuing a dog who was trapped in a mudslide. He has also received numerous letters of praise from outside agencies for his immeasurable involvement with their computer systems; and

WHEREAS, DUANE BOLTON'S dedication to public service is amply demonstrated by the many letters of gratitude from Daly City residents and others to whom he provided services. He has been described as a true gentieman, extremely polite and understanding. A citizen who had been victimized in a sexual assault wrote, "He offered a great deal of support and strength to me during those difficult hours after my attack. He is an invaluable asset to the department and a truly fine police officer and a gentleman."
