AGREEMENT TO RELINQUISH DEVELOPMENT RIGHTS

The following Agreement is entered into on this _____ day of October, 2003, by and between Sean Kent and Chantellie Kent, husband and wife as community property, as owners of the certain real property as fully described below (hereinafter "Owners"), and the COUNTY OF SAN MATEO, a political subdivision of the State of California (hereinafter "County");

WITNESSETH

WHEREAS, in an agreement dated September 26, 1983, Marie A. Spinetti, (the Owners' predecessor in interest) by Agreement to Dedicate Development Rights, dedicated all development rights to the County in the real property described in Exhibit A to this agreement (the "Property"), which Exhibit is incorporated herein by reference, in consideration of the release from assessment for a sewer connection by the Emerald Lake Hills Wastewater Project Assessment District;

WHEREAS, the Owners now desire to have certain development rights reinstated in said property;

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the County and Owners agree as follows:

- 1. Owners declare that they are the current owners of record of the Property.
- 2. County hereby relinquishes to Owners all of the rights to the Property set forth in the Agreement to Dedicate Development Rights dated September 26, 1983.
- 3. Owners hereby accept from County all such rights.
- 4. Owners agree that as a result of this Agreement, the Property is subject to inclusion in the Emerald Lake Hills Wastewater Management Project Assessment District (the "District") and Owners hereby agree to pay all applicable assessments of the District.
- 5. Entering into this Agreement does not constitute an agreement or representation that the County or the sewer maintenance district will grant or approve development permits or applications for such permits.
