WHEREAS, MARY H. JANNEY is the recipient of honors and awards including the California State PTA Honorary Life Membership Award, the Burlingame School District Jay Burns Award, the Burlingame Chamber of Commerce Distinguished Citizen Award and induction into San Mateo County's Women's Hall of Fame in 1992; and

WHEREAS, MARY H. JANNEY holds a Bachelor of Arts Degree from Duke University and attended Graduate programs at the University of Washington, the College of Notre Dame, San Diego State, San Francisco State and San Jose State. She also earned lifetime Elementary and Secondary Teaching Credentials.
