SECOND AMENDMENT TO THE AGREEMENT WITH TAMMY DAWSON. Esq.

THIS SECOND AMENDMENT TO THE AGREEMENT, entered into on this day ______2004, by and between the COUNTY OF SAN MATEO, hereinafter-called "County", and the TAMMY DAWSON. Esq. hereinafter called "Contractor"

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department/Agency thereof; and

WHEREAS, it is necessary and desirable that Contractor be retained for the purpose of performing the professional services for Human Services Agency, Children and Family Services.

WHEREAS, the parties have previously entered into an Agreement with Tammy Dawson, Esq, dated September 11, 2001, for legal immgration services and;

WHEREAS, the Agreement has been amended on on prior occision and;

WHEREAS, the parties now wish to further amend the Agreement to add \$50,000 and to extend the term of the Agreement from July 1, 2001 through June 30, 2004 to July 1, 2001 through June 30, 2006.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES AS FOLLOWS:

1. Section 2 – Contract Term, is amended to read as follows:

<u>**Contract Term**</u> The term of this Agreement shall be from <u>July 1, 2001</u> to <u>June 30</u>, <u>2006</u> unless terminated earlier by the County.

2. Section 3 – Payments, is amended to read as follows :

Payments In consideration of the services rendered in accordance with all terms, conditions and specifications set forth herein and in Exhibit "A", County shall make payment to Contractor in the manner specified herein and in Exhibit "A". In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall total payment for services under this Agreement exceed <u>ONE HUNDRED TWENTY FOUR</u> **THOUSAND DOLLARS (\$124,000).**

All other terms and conditions of the agreement dated September 11, 2001, as amended on June 25, 2002 shall remain in full force and effect.
