#### 1. <u>LICENSE</u>

Licensor hereby gives permission, revocable and terminable as hereinafter provided, to Licensee to enter the Licensed Premises for the purpose of using it for the improvements to its communications system equipment and operations (hereinafter referred to as the "Improvements"). Said Improvements shall be located so as to not interfere with any of the Licensor's operations.

#### 2. <u>USE OF LICENSED PREMISES</u>

Licensee shall be permitted to use the Licensed Premises for the operation of communications equipment and related purposes. Licensee shall not be permitted to use the Licensed Premises for any other purpose except by prior written permission of Licensor.

#### 3. <u>TERM</u>

The initial term of this license shall run from October 1, 2004 to September 30, 2005 (base year). Licensee may extend the term of the license for up to nine additional one-year option periods. Each option period shall run from October 1 until September 30 so as to conform to the Government's fiscal year.

Licensor or Licensee may terminate this Agreement by giving three (3) months written notice to the other party of its termination.

#### 4. <u>ACCESS</u>

Licensor shall provide Licensee access to the Licensed Premises at all times for the uses authorized herein.

#### 5. MAINTENANCE

The costs of any maintenance and operations of the Improvements shall be at the sole expense of Licensee.

#### 6. ASSUMPTION OF LIABILITY FOR INJURIES

Licensee assumes liability for claims and/or liability of personal and property damages arising out of the acts, omissions, or negligence of the Licensee or its employees acting within the scope of their employment (1) in the operation and maintenance of the herein Licensed Premises or (2) the failure of the Licensee or its employees acting in the scope of their employment to observe and abide by any of the terms of conditions of this License Agreement. This assumption of liability is coexistent with and in accordance to the liability of the Government under the Federal Tort Claims Act (Title 28, USC, Section 2671-2680). Claims for tort damages shall be submitted and adjudicated in accordance with the procedures of the Federal Tort Claims Act and applicable state and Federal law.

Additionally, in the event an FBI employee conducting official business during the use of the leased premises is injured, the FBI agrees to process and forward any claims for employee compensation to the United States Department of Labor (USDOL) pursuant to the Federal Workman's Compensation statutes (Title 5, U.S.C., Section 8108, et. Seq.) and pertinent regulation promulgated by the USDOL.

Licensee, as an agency of the United States Government, is self-insured and shall be considered so in this License.

## 8. <u>INTERFERENCE</u>

In the event the Licensor determines that the operation of the Improvements by Licensee caused interference to transmission and/or reception of any other communications systems in use in the vicinity of the Licensed Premises, Licensee shall take all appropriate steps necessary to mitigate said interference within thirty (30) days of receiving written notice.

## 9. <u>PERMIT</u>

Licensee is responsible for obtaining and paying the costs of all permits, licenses or other approvals by any regulatory body having jurisdiction over the uses authorized herein.

## 10. <u>COMPLIANCE</u>

Should Licensee fail or neglect to comply with any terms or conditions of this BOA or to comply with any reasonable requirement of Licensor after thirty (30) days written notice and demand, this BOA shall be subject to termination. In the event of such termination, Licensee shall immediately remove any and all of its Improvements from the Licensed Premises and surrender all rights and privileges under this License Agreement.

## 11. <u>POSTING OF FREQUENCIES</u>

All Federal government frequencies are authorized by the Department of Commerce (DOC) and are exempt from disclosure under the Freedom of Information Act. Frequencies cannot be posted at communications sites. Copies of DOC frequency authorizations can be provided to communications site owners or managers upon request.

#### 12. ASSIGNMENT

In accordance with 41 U.S.C. 15, Licensor shall not assign this Agreement, or sub-license all or any part of its rights and obligations hereunder without the prior written notice to Licensee. The written notice shall include documents describing the proposed transaction, e.g. purchase/sale agreement or memorandum of understanding. The new Licensor assumes all the obligations under this License Agreement and is in a position to fully perform all obligations that may exist under this Agreement. The previous Licensor waives all rights under this BOA against the Licensee. Nothing in this Agreement shall relieve the parties from compliance with any Federal law.

## 13. <u>DISPUTES</u>

Disputes under this License Agreement shall be resolved in accordance with the FAR 52.233-1, 41 USC 601-613 Disputes and Appeals.
