El Granada Roadway and Drainage Improvement Project –

Mid-Coast Area

(County Project No. R6F00, R6G00 & R6H00)

Description of Work Completed

The work that was completed, consisted in general, of the construction of new storm drain facilities (drain pipes, storm inlets and sub drains), replacement of the existing roadway structural section by grading, compacting, and cement treating native material, placement of asphalt concrete pavement, construction of retaining walls (structural and gravity) and construction of parking lanes, curb, gutter, and sidewalk on Paloma Avenue (between Valencia Avenue and San Carlos Avenue), and construction of concrete valley gutters on Paloma Avenue (between San Carlos Avenue and Ferdinand Avenue), San Carlos Avenue (between Paloma Avenue and Carmel Avenue), Escalona Avenue, Navarra Avenue, Ferdinand Avenue (between Escalona Avenue and Carmel Avenue) and San Juan Avenue (between Ferdinand Avenue and Carmel Avenue), as well as additional items not mentioned above, but required by the Project Plans and Standard Specifications.

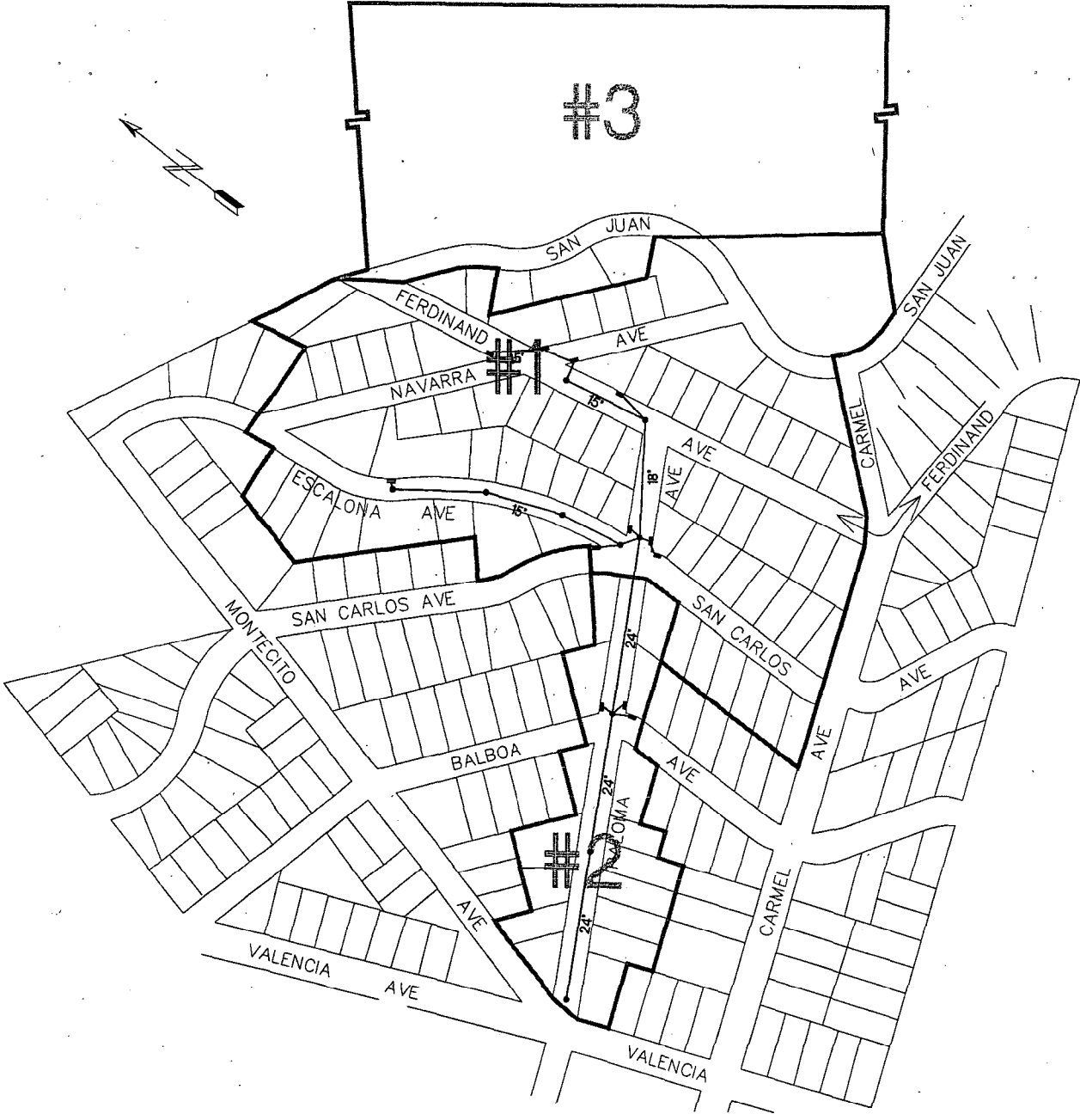
