THIS IS TO CERTIFY THAT the San Carlos Planning Commission at a regularly scheduled meeting thereof, held on February 7, 2000, did grant a Conditional Use Permit to San Mateo County Information Services Department, to permit the upgrade of radio systems equipment at 700 Crestview Drive (APN 049-400-010) pursuant to Municipal Code Section 18 28 030 (B)(1) The application was approved with the following conditions

- Construction shall be as indicated in plans received January 21, 2000 Any substantial changes to the plans shall require re-review by the Planning Commission by Public Hearing
- 2 Any addition or modifications to the antenna structure shall be approved by Planning Staff and the Building Department before being installed
- 3 The applicant shall work with the neighbors to resolve any noise related complaints associated with the proposed equipment
- The applicant shall comply with all requirements of the Building Department, including, but not limited to, the following
  - a Address assignment for this site is 700 Crestview Drive, please post on entry gate in 4" minimum letters
  - b The 60' antenna requires full wind, seismic and gravity load calculations from a California registered engineer
  - c A geotechnical report is required
  - d The 240 square foot equipment building and antenna require building permits
  - e The equipment building can be conventional construction or designed by a licensed engineer
  - The equipment building appears to be 2' away from the property line, a firewall is required where less than 3'
  - g The location and approval of the propane tank is under the authority of the South County Fire District The plumbing is required to comply with the California Plumbing Code
- 5 The antenna tower shall be painted light gray in color, and the communications shelter and propane tank shall be painted in earth tones to the satisfaction of Planning Staff
- If the antennae remains non-operational for a period of six (6) months or longer, the antennae shall be considered abandoned and the applicant shall remove the antennae from the site
- 7 Landscaping shall be installed along the southern property line to the satisfaction of Planning Staff
